Re: Notification of the Transfer of Ultimate Control of Comcast Business Communications, Inc. and AT&T Broadband Phone of Kentucky, LLC to AT&T Comcast Corporation

Dear Mr. Dorman:

On March 4, 2002, Comcast Business Communications, Inc., d/b/a Comcast Long Distance ("CBC"), by its attorneys, filed with the Kentucky Public Service Commission (the "Commission") a Notification regarding the transfer of ownership and control of CBC's ultimate parent, Comcast Corporation ("Comcast"), and thus also CBC, to a newly-created ultimate parent, AT&T Comcast Corporation. On March 7, 2002, AT&T Broadband Phone of Kentucky, LLC ("AT&T Broadband Phone of Kentucky") filed with the Commission a Notification regarding the indirect transfer of ownership and control of AT&T Broadband Phone of Kentucky to AT&T Comcast Corporation. This letter is to advise the Commission that the transactions that were the subject of the Notifications have been completed.

As part of the consummation of the transactions, the names of certain parties were modified. AT&T Comcast Corporation is now known as Comcast Corporation, and is the ultimate parent company of CBC and AT&T Broadband Phone of Kentucky. The former Comcast Corporation has now been renamed Comcast Holdings Corporation. The immediate parent of AT&T Broadband Phone of Kentucky was AT&T Broadband Phone, LLC, and its name has been changed to Comcast Phone, LLC. The new entity formed as part of the merger transaction, whose shares were spun off to the shareholders of AT&T Corp., originally was named AT&T Broadband Corp. and its name has been changed to Comcast Cable Communications Holdings, Inc. A chart describing the completed transaction before and after these name changes is attached hereto as *Exhibit A*. Because all of the above entities whose

names have been changed function only as holding companies, they are not required to qualify to do business in the State of Kentucky under their new names.

With respect to CBC, the change in control approved by the Commission is transparent to customers in the State of Kentucky, as CBC continues to provide the same services to its Kentucky customers pursuant to the same authorization. AT&T Broadband Phone of Kentucky also will continue to provide the same services to its Kentucky customers pursuant to the same authorization, but Comcast Corporation shortly will pursue the procedures necessary to change its name and will provide the appropriate notice to customers. 

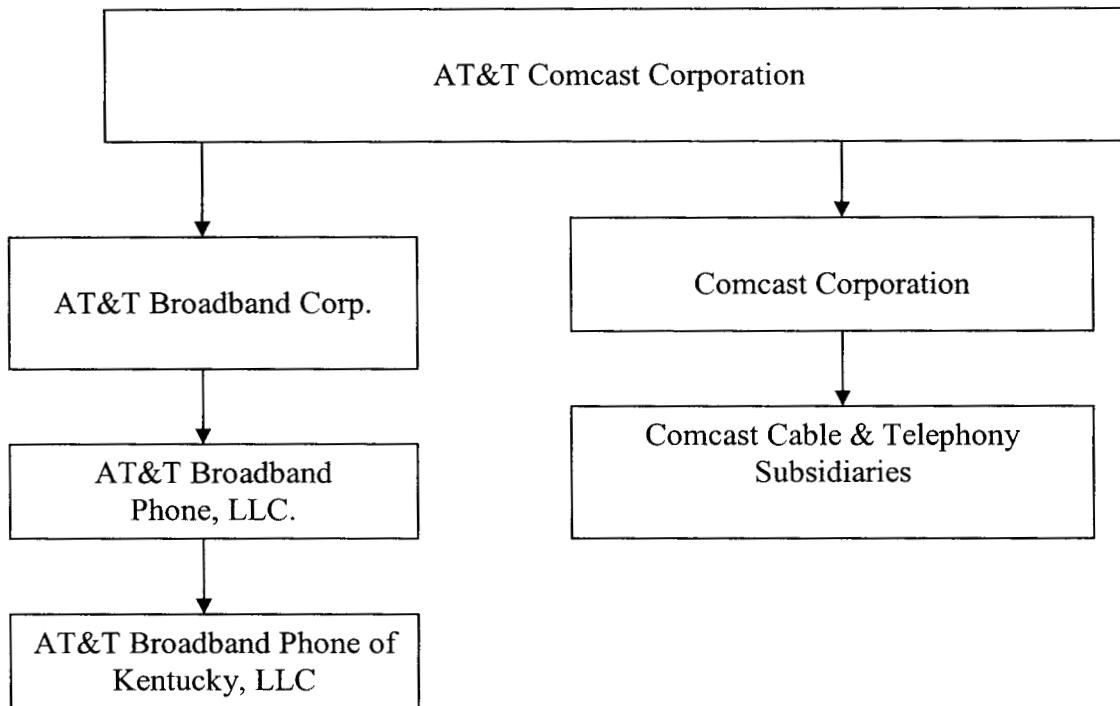

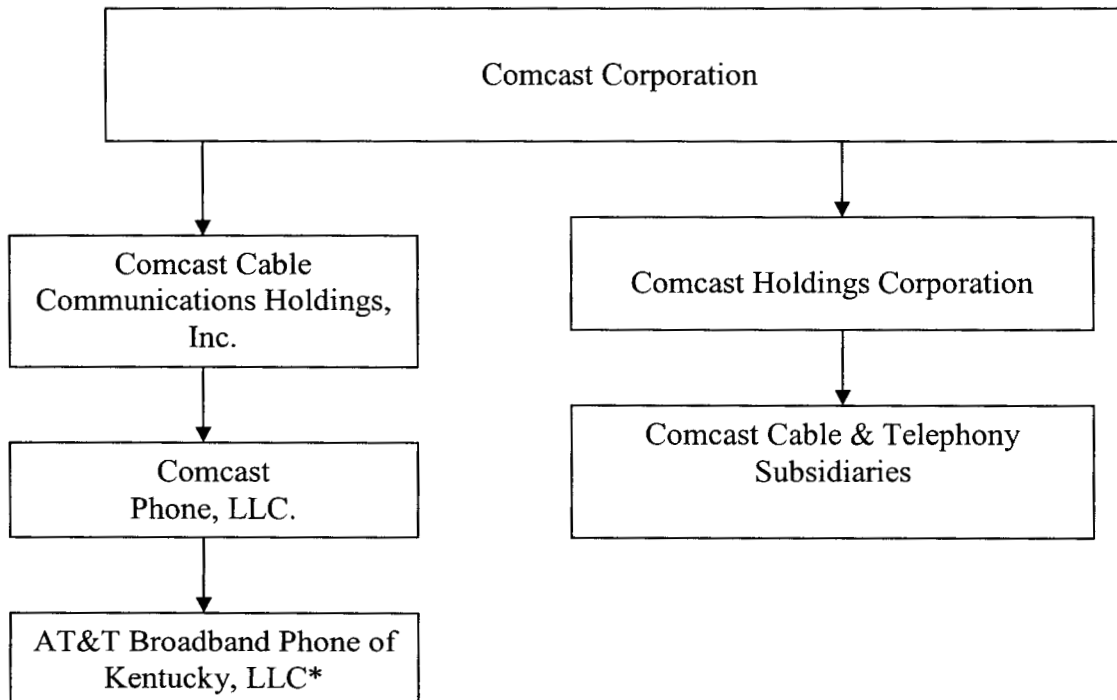
**ORGANIZATIONAL CHARTS**
