RE: Application for Authority to Transfer Ownership or Control of Enhanced Communications Network, Inc. to Pacific Telecom, Inc.

Dear Ms. Helton:

Enhanced Communications Network, Inc. ("ECN") by its attorneys, hereby notifies the Kentucky Public Service Commission ("Commission") of the proposed transfer of control of ECN from its current shareholder to Pacific Telecom, Inc. ("PTI"). It is our understanding that under the circumstances set forth below, no formal approval of the Commission is required for this transaction.

ECN, a Delaware corporation, is currently authorized to provide intrastate toll telecommunication services in Kentucky.¹ ECN is currently authorized as a reseller of intrastate, interexchange telecommunications services in 44 states. It also is authorized by the Federal Communications Commission to resell interstate and international service.

PTI is a corporation duly incorporated, validly existing and in good standing under the Laws of the State of Delaware.

On May 31, 2001, PTI entered into a Stock Purchase Agreement whereby ECN's shareholders will transfer all of the outstanding shares of ECN to PTI. The transfer of control of ECN from its current shareholder to PTI is in the public interest. The addition of ECN to PTI's other interests will enhance ECN's ability to compete in the market for telecommunication services in Kentucky and elsewhere. After the transaction, ECN will continue to operate as it has in the past, using the same names, tariff, and operating authority. PTI intends to retain all key ECN personnel, including certain senior management

personnel. Thus, the transfer of ownership or control will be transparent to, and have no adverse impact upon the ECN customers. The benefit from increased economies of scale will permit ECN to operate more efficiently and thus to compete more effectively.

As a result of this transaction, ECN will have access to the financial resources it needs to introduce new products and services and to respond to competition in the competitive telecommunications environment in Kentucky. Over time, consumers in Kentucky will benefit from a greater number of products and service options, as well as lower prices.


