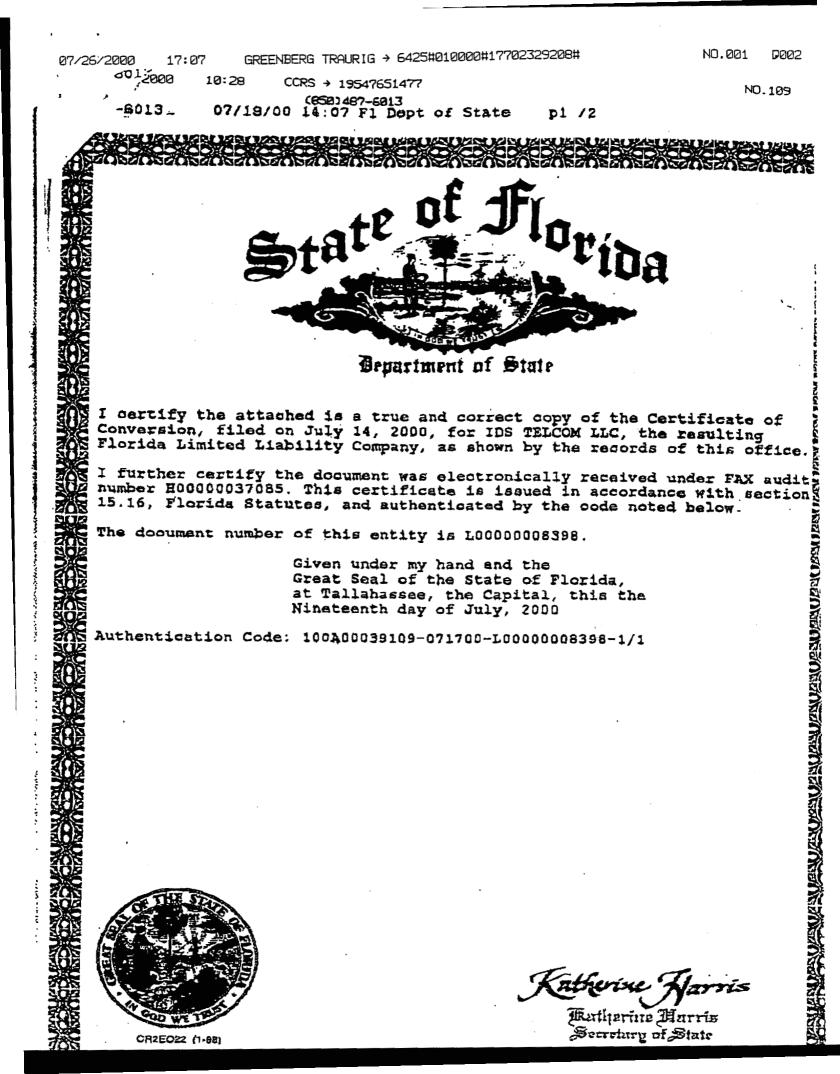

# **BIOGRAPHICAL INFORMATION**

The three owners of IDS Telcom have a common background; they have each built companies from the ground up. Be it in telecommunications, retail, real estate, construction, the automobile or restaurant industries, these men have each demonstrated a unique ability to know what sells, when to sell it and most importantly, how to sell it.

# Mr. Joe Millstone, Chief Executive Officer

Mr. Joe Millstone is a founding member of IDS. He, along with his father, Burris Millstone, and Michael Noshay, were three visionaries who came together in the late 80's to pool their talents and fill a void in the telecommunication needs of small businesses.

Joe Millstone began his career at the early age of 20 as the owner/operator of an audio-stereo equipment store that grew into a chain of stores. Mr. Millstone oversees every aspect of the retail side of IDS Telcom along with the sister company, Interconnect Data Service (the telephone equipment side of the house). Mr. Millstone manages everything from the purchase of switching equipment and the development of point of sale materials to billing and collections.

### Mr. Michael Noshay, President

Mr. Noshay is also a founding father of IDS. Mr. Noshay has a vast wealth of experience in various businesses including construction, real estate, manufacturing, distribution and the hotel industry. His relationships helped to

establish a customer base that secured the company's revenue stream at a critical time.

Mr. Noshay has had over 10 years experience in the telecommunications industry. At IDS Telcom, Mr. Noshay is responsible for the development and negotiation of all interconnection agreements with companies such as BellSouth, Bell Atlantic, GTE and Sprint, to name a few, along with several PTT agreements with foreign countries. He handles all of the legal and contractual situations that arise within the business, including regulatory issues and billing disputes. He also is responsible for maintaining tariffs and certain licensing requirements for the company.
