Please be advised that, on September 5, 2012, STi Prepaid, LLC filed a voluntary petition for relief under Chapter 11 of the U.S. Bankruptcy Code in the US Bankruptcy Court for the Southern District of New York, Case No. 12-13811. A copy of the petition is attached hereto.

With regard to any amounts owed prior to September 5, 2012, there is now an automatic stay in place that precludes creditors and other parties from taking certain collection and other actions against STi without prior approval from the Bankruptcy Court. Any attempt to collect a pre-petition debt or take other action in violation of the Bankruptcy Code is subject to contempt of court proceedings.
