Re: Notice of Indebtedness and Guarantee

Dear Sir or Madam:

This letter is filed on behalf of Interstate FiberNet, Inc. ("IFN"), DeltaCom, Inc. ("DeltaCom") and Business Telecom, Inc. d/b/a BTI ("BTI") (collectively, the "Companies"). The ultimate parent company of the Companies is ITC^ΔDeltaCom, Inc. ("ITCD"). The purpose of the letter is to inform the Commission of a proposed transaction whereby ITCD will deleverage its balance sheet and enhance its liquidity profile through certain credit facilities (the "Facilities") provided by Tennenbaum Capital Partners, LLC, Credit Suisse, Credit Suisse Securities and certain of their affiliates. The Facilities will serve to reduce and refinance ITCD's outstanding debt (and the debt of its subsidiaries) leaving ITCD with \$305 million of first and second lien funded debt, a \$10 million undrawn revolver, approximately 81 million shares of common stock outstanding on a fully diluted basis, and cash on hand of approximately \$50 million. The loan will be secured by the assets of IFN and the guarantees of ITCD, DeltaCom and BTI. IFN will serve as the primary obligor of the Debt while DeltaCom, BTI and ITCD will serve as guarantors.

IFN is wholly-owned subsidiary of ITCD and is headquartered at 7037 Old Madison Pike, Huntsville, Alabama 35806. IFN is a provider of wholesale fiber optic transmission or commonly known as a carrier's carrier. IFN obtained is not certified in this state, but has a tariff on file as 9/10/97.

DeltaCom is a wholly-owned subsidiary of IFN which, in turn, is wholly owned by ITCD and is headquartered at 7037 Old Madison Pike, Huntsville, Alabama 35806. DeltaCom is incorporated under the laws of the state of Alabama and is qualified to transact business in this state as a foreign corporation. DeltaCom received its authority to provide long distance telecommunications services in this state pursuant Docket No. 94-201 dated 10/4/94.


BTI is wholly owned subsidiary of ITCD and is headquartered at 7037 Old Madison Pike, Huntsville, Alabama 35806. BTI is incorporated under the laws of the state of North Carolina and is qualified to transact business in this state as a foreign corporation received its authority to provide long distance telecommunications services in this state pursuant Docket No. 92-367 dated 12/8/92 and competitive local telecommunications services in this state on 7/8/98.

The subject transaction will not result in a change of control of any entity. The transaction will enable the Companies to achieve better liquidity and capitalization, which in turn, will enhance their ability to provide quality services to customers of this State at competitive prices, thereby serving the public interest.

This letter is filed for informational purposes to keep the Commission abreast of the financial activities of these certificated Companies. It is our understanding that no action by the Commission is necessary.
