Re: Notification Regarding the Proposed Transfer of Indirect Control of Neutral Tandem-Kentucky, LLC to Onvoy, LLC

Dear Mr. Derouen:

By this letter, Onvoy, LLC ("Onvoy" or "Transferee"); Neutral Tandem-Kentucky, LLC ("Neutral Tandem") and Inteliquent, Inc. ("Inteliquent") (collectively, the "Parties") notify the Commission of the transfer of indirect control of Neutral Tandem to Onvoy. Pursuant to the Orders issued in Admin. Case No. 359 on June 21, 1996 and Admin. Case No. 370 on January 8, 1998 and 807 KAR 5:011, Section 11, prior action by the Commission is not required for the transactions described herein. Accordingly, the Parties submit this letter for informational purposes.

## **Description of the Parties**

## A. Onvoy, LLC

Onvoy is a Minnesota limited liability company with a principal office at 10300 6th Avenue North, Plymouth, Minnesota 55441. Onvoy is an indirect, wholly owned subsidiary of GTCR Onvoy Holdings LLC ("Parent"). Onvoy has provided telecommunications services since 1988.

Founded in 1980, GTCR LLC is a private equity firm focused on investing in growth companies in the Financial Services & Technology, Healthcare, Technology, Media &

Parent is a Delaware limited liability company with its principal executive office at 300 N. LaSalle Street, Suite 5600, Chicago, Illinois 60654. Parent is an investment vehicle created to aggregate the ownership of various investment funds managed by GTCR LLC in connection with the acquisition by such funds of Onvoy and its subsidiaries. Upon completion of *the Inteliquent Merger* (as defined below), the following funds are expected to own ten percent (10%) or more of Parent: GTCR Fund X/A LP (approximately 70.4%); and GTCR Fund X/C LP (approximately 20.2%).

Onvoy provides primarily wholesale local exchange and long distance services, switched access, transit and other services to other carriers and communications providers. Onvoy and/or one or more of its subsidiaries is authorized to provide intrastate telecommunications services in the District of Columbia and in every U.S. state. In Kentucky, Onvoy is registered as a Competitive Local Exchange Carrier (Utility ID 5057170) and as a Long Distance Carrier (Utility ID 5179720). In addition, the following wholly owned subsidiaries of Onvoy are authorized to provide intrastate telecommunications services in Kentucky: Broadvox CLEC, LLC ("BV-CLEC"), is registered in Kentucky as a Competitive Local Exchange Carrier (Utility ID 5056340) and as a Long Distance Carrier (Utility ID 5178700); and ANPI Business, LLC ("ANPI-Biz") (formerly known as of Zone Telecom, LLC) is registered as a Long Distance Carrier (Utility ID 5156400). Onvoy, BV-CLEC and ANPI-Biz are also authorized by the FCC to provide domestic and international telecommunications services.

## B. Neutral Tandem-Kentucky, LLC and Inteliquent, Inc.

Neutral Tandem, a Delaware limited liability company, is a direct, wholly owned subsidiary of Inteliquent with a principal office at 550 W Adams St, 9th Floor, Chicago, IL 60661. Neutral Tandem and its affiliates provide intrastate telecommunications services throughout the United States. In Kentucky, Neutral Tandem is registered as a Competitive Local Exchange Carrier (Utility ID 5055450) and as a Long Distance Carrier (Utility ID 22255450). Inteliquent is authorized by the FCC to provide interstate and international telecommunications services.

## **Description of the Inteliquent Merger**

Pursuant to the Agreement and Plan of Merger, dated November 2, 2016, by and among Onvoy; Onvoy Igloo Merger Sub, Inc. (a wholly owned direct subsidiary of Onvoy created for purposes of the merger) ("Merger Sub"); and Inteliquent, Onvoy will acquire all of the outstanding equity interest in Inteliquent (the "Inteliquent Merger"). Specifically, Merger Sub will merge with and into Inteliquent, whereupon the separate existence of Merger Sub will cease and Inteliquent will be the surviving corporation. As a result, Inteliquent will become a direct, wholly owned subsidiary of Onvoy. Neutral Tandem will remain a direct subsidiary of Inteliquent and, therefore, will become an indirect subsidiary of Onvoy. Diagrams depicting the pre- and post-transaction corporate organization structures are appended hereto as Exhibit A.

The Inteliquent Merger will bring together two successful enterprises that have demonstrated a long-standing commitment to excellence in a highly competitive marketplace. The combined financial, technical, and managerial resources of Onvoy and Inteliquent are expected to enhance the ability of their regulated subsidiaries (collectively the "Licensees") to compete in the telecommunications marketplace. At the same time, the Inteliquent Merger will have no adverse impact on the customers of Neutral Tandem. Immediately following the Inteliquent Merger, Neutral Tandem will continue to provide high-quality services at the same rates and on the same terms and conditions as are currently in effect. Further, the current customers of Neutral Tandem will remain customers of Neutral Tandem immediately following the Inteliquent Merger. The only change immediately following closing of the Inteliquent Merger will be that that Neutral Tandem's ownership will change, with Onvoy and ultimately Parent as the new owners. Since the Inteliquent Merger will occur at the holding company level with Inteliquent as the entity surviving the merger, it will be completely transparent and seamless from a customer's perspective.





## Pre-Inteliquent Merger Corporate Ownership Structure of "Neutral Tandem"




## Post-Inteliquent Merger Corporate Ownership Structure of Neutral Tandem
