On behalf of TOTALink of Kentucky, LLC ("TOTALink" or the "Company"), enclosed for filing are an original and four (4) copies of this letter of intent, as well as TOTALink's proposed tariffs. In accordance with the Commission's Orders in Administrative Case No. 359 (dated June 12, 1996), Administrative Case No. 355 (dated September 26, 1996), and Administrative Case No. 370 (dated January 8, 1998), TOTALink submits the following information:

2. TOTALink is a limited liability company organized under the laws of the State of Delaware. A copy of TOTALink's Certificate of Formation is attached hereto as Exhibit A. TOTALink is in the process of applying for its Certificate of Authority to transact business in Kentucky and will forward the Certificate to the Commission as soon as it is granted.

TOTALink will be available, during regular business hours, at its toll-free number for customer inquiries. TOTALink's toll-free number for customer inquiries will be set up once the office is opened.

4. TOTALink has not provided nor collected for intrastate telecommunications service in Kentucky prior to filing this notice of intent and accompanying tariffs. Please see notarized statement attached hereto at Exhibit B.
5. TOTALink does not currently seek to provide operator assisted services to traffic aggregators as defined in Administrative Case No. 330, but it will comply with the Commission's mandates in Administrative Case No. 330 in the event it does provide such services.
6. TOTALink seeks authority to provide all forms of facilities-based local exchange and interexchange telecommunications services to customers throughout the State of Kentucky.¹ Applicant will offer services, which allow its customers to originate and terminate local calls to other customers served by TOTALink as well as customers served by all other authorized local exchange carriers. Specifically, TOTALink intends to provide all forms of local exchange services authorized by the Department including: (1) Basic Residential Exchange Services (Local Exchange Flat Rate, Measured Rate Service, operator access, etc.); (2) Residential Custom and Class Features (call waiting, caller ID, call forwarding, etc.); (3) Basic Business Exchange Services; (4) Business Custom Calling and Class Features; and (5) Business and Residential Ancillary Services (911, directory assistance, etc.). In addition, TOTALINK will also provide resold and facility-based interstate and international interexchange services (subject to appropriate FCC licenses).

¹ Please note that, although TOTALink seeks authority to provide local exchange services on a statewide basis, TOTALink does not, at this time, seek to terminate any small or rural LEC exemption claimed by any incumbent in Kentucky.
