Intrado Communications Inc. hereby provides notice relating to the transfer of controlling interest in the stock of its parent, Intrado Inc. ("Intrado"), by West Corporation.

As a result of this transfer, Intrado will become a wholly-owned subsidiary of West Corporation.

Intrado Communications Inc. will continue to report in Kentucky under the name of Intrado Communications Inc. Intrado Communications Inc. was authorized to provide competitive telecommunications services in the State of Kentucky under the name Intrado Communications Inc. granted on July 20, 2001. Intrado Communications Inc. does not currently have any customers and does not provide service in Kentucky.

I. THE COMPANY ACQUIRING THE PARENT OF INTRADO COMMUNICATIONS INC.

West Corporation is a company organized under the laws of Delaware with its principal office located in Omaha, Nebraska.

West Corporation is not certificated in the State of Kentucky to provide telecommunications services. West Corporation does not offer domestic retail telecommunications services. West Corporation is a leading provider of outsourced communication solutions to many of the world's largest companies. West's integrated suite of customized solutions includes customer acquisition, customer care and retention services, interactive voice response services, and conferencing and accounts receivable management services. Founded in 1986 and headquartered in Omaha, Nebraska, West has approximately 28,100 employees based in North America, Europe and Asia.

West Corporation is a publicly held company with approximately 43 affiliated entities in business-to-business communication services, conferencing services and receivables management. A complete description of West Corporations' services is available in its public filings at www.sec.gov. West Corporation has more than sufficient resources to ensure the successful ongoing operations of Intrado.

II. THE AGREEMENT

On January 29, 2006, Intrado entered into an Agreement and Plan of Merger. As a net result of the merger, West Corporation will own 100% of the outstanding shares of Common Stock in Intrado, making Intrado a wholly-owned subsidiary of West Corporation. Intrado Communications Inc. will remain a wholly-owned subsidiary of Intrado. There will be no material changes in the day-to-day management of Intrado or Intrado Communications Inc., and there is no customer base to be impacted by this transaction. This Agreement and Plan of Merger does not contemplate that West Corporation will operate directly in Kentucky as a telecommunications services provider.

III. CUSTOMER IMPACT

Intrado Communications Inc. does not currently have any customers and does not provide service in Kentucky. Therefore there is no customer impact associated with this transaction. The proposed transfer will have no effect on Intrado Communications Inc.'s name, address, contact information, services, rates or terms and conditions of service. Neither the management team of Intrado or Intrado Communications Inc. is anticipated to be dramatically affected by the transfer of control.
