Dear Mr. Dorman:

The purpose of this letter is to notify you that Williams Local Network, Inc. ("Williams"), changed its name. Williams' legal name is now Williams Local Network, LLC. Williams has authority in Kentucky to provide intrastate interexchange telecommunications. Accordingly, please update applicable Commission records and mailing lists to reflect the name change. Enclosed for filing is an appropriately amended Tariff No. 1 that reflects the name change of the company. For your files, we have also enclosed a copy of Williams approved application for certificate of authority from the Kentucky Secretary of State, as evidence that Williams duly registered to transact business in Kentucky as a foreign limited liability company under the new name.


The name change is the result of the conversion of Williams from a corporation to a limited liability company under Delaware law effective January 1, 2001. Nothing in that conversion process resulted in a change of control or assignment of Williams' regulatory authorizations or negatively affected Williams' ability to offer services.
