RE: Proposed Boundary Between AT&T Kentucky's Finchville and Taylorsville Exchanges


Dear Mr. Derouen:

Please find attached a revised tariff filing from Kentucky Tariff 2A, Exchange Service Area Maps, in which we propose to change the boundary between the Finchville and Taylorsville exchanges, to be effective October 28, 2009. Enclosed are copies of the current Finchville and Taylorsville Exchange maps with the proposed changes penciled in red.

A new residential subdivision, Top Flight, is under construction in Spencer County. The majority of the subdivision is in the Finchville exchange and a small portion falls in the Taylorsville exchange. This proposed tariff change will allow any potential subscriber in the subdivision to be served from the same exchange, Finchville. It is more economical for AT&T Kentucky to serve this subdivision from the Finchville exchange. Additionally, there are no customers impacted by this proposed boundary change since the land was previously undeveloped.


