Please find enclosed revised tariff pages of Section A3 of the General Subscriber Services tariff. This filing increases the Monthly Exchange Rates for Flat Rate Residence and Business Service as provided for in KRS 278.543 for electing companies. While AT&T Kentucky's election on July 12, 2006 capped rates for 60 months, this will be the first change to the tariff rate for these services in nearly a decade.

The effective date of the price changes is December 17, 2011. Notice to affected customers via a bill message began on November 15, 2011. Attachment A contains a copy of the notices.
