
Consistent with BellSouth Telecommunications Inc., d/b/a AT&T Kentucky July 12, 2006 letter of election into HB337 and our ongoing effort to move non-basic services from AT&T Kentucky tariffs to its guidebook, AT&T is filing the following changes to remove non-basic retail and business services from the General Subscriber Services Tariff on file with the Kentucky Public Service Commission. These services will remain in AT&T Kentucky's General Exchange Guidebook found at <http://cpr.att.com/pdf/ky/kyGBookDesc.htm>. Tariff changes associated with this filing include:

- Section A1 – Definitions of Terms no longer remaining in the Tariff are being removed
- Section A3 – Individual Rate Exchange prices removed (now refers to main schedule, shown by Rate Group)
- Section A3 – Directory Assistance, Local Operator Services and Directory Assistance Call Completion Service removed from Tariff
- Section A5 – Construction Charges and Charges for Unusual Installations removed from Tariff
- Section A7 – Coin Telephone Service removed from Tariff
- Section A18 – Long Distance Telecommunications Service removed from Tariff
- Section A119 – Obsolete Wide Area Telecommunications Service removed from Tariff

Additionally, Subject Index and Title Page Service Marks are removed for Services no longer appearing in the Tariff.


