

NOTICE

Former Overland Development customers:

On February 10, 2016, the Public Service Commission ("PSC") approved the acquisition of Overland Development Inc. ("Overland") by Big Sandy Water District ("Big Sandy").

Big Sandy plans to file with the PSC on or before June 1, 2016, to cancel the Overland tariff, with the exception of the Overland monthly water usage rates, which will remain the same for now, and transition former Overland customers to being served under the Big Sandy tariff effective July 1, 2016.

Below is the list of non-recurring charges that appear in the Overland tariff. Effective July 1, 2016, these charges will be replaced by the Big Sandy charges mentioned later in this notice.

The transitioning of former Overland customers to the Big Sandy tariff is being proposed by Big Sandy, but the PSC may order changes that differ from the proposal contained in this notice.

A person may submit a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, KY 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the PSC does not receive a written request for intervention within thirty (30) days of the initial publication or mailing of this notice, the PSC may take final action on the tariff filing.
