**AN ORDINANCE ESTABLISHING NEW WATER RATES AND AMENDING CITY OF
TOMPKINSVILLE ORDINANCE NO. 13-_____**

BE IT HEREBY ORDAINED by the City of Tompkinsville, Kentucky, as follows:

Section 1. WHEREAS, the rate at which the City of Tompkinsville shall sell water to its retail customers shall be increased as follows beginning the 16th day of January, 2016.

- a. The first 2,000 gallons: \$19.00
- b. The next 5,000 gallons: \$ 4.75
- c. Over 8,000 gallons: \$4.25
- d. The wholesale rate shall be: \$2.25 per 1,000 gallons

Section 2. This ordinance hereby rescinds, repeals, and replaces Ordinance #2010-11-15A and Ordinance #13-_____, pertaining to the establishment of water rates.

Section 3. This ordinance shall be effective upon two consecutive votes of the Tompkinsville City Commission and publication according to law.
