O R D E R

On the Commission's own motion, IT IS HEREBY ORDERED as follows:

1. No later than 20 days from the date of this Order, Tsaconas Cellular, Inc. ("Tsaconas Cellular") shall mail, postage prepaid, the written notice set out in appendix A, attached hereto and incorporated herein, to each and every resident/tenant whose dwelling lies within 500 feet of the proposed tower sites and to each and every owner of property within 500 feet of the proposed tower sites of the application. The map showing the location of the proposed tower shall be attached to this notice.

2. Within 10 days after completion of the above required notification, Tsaconas Cellular shall file an affidavit, the original and six copies, with the Commission verifying full compliance with this notice requirement including, but not limited to, listing the name and address of each resident and property owner who received the notice, the date the notice was mailed,

and attaching a true copy of the written notice given to the residents and property owners.

3. Within 20 days of the date of this Order, Tsaconas Cellular shall file its proposed tariff, the original and six copies, setting forth all rates, rules and regulations governing the provision of service in accordance with 807 KAR 5:011.
