O R D E R

On June 11, 1992, Henderson County Water District ("Henderson") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds that:

1. Henderson's supplier, city of Henderson ("City") increased its rate for wholesale water from \$.75 to \$.7989 per 1,000 gallons effective May 18, 1992.

2. Henderson increased the rates to its customers effective June 1, 1992. Based on an average usage of 5,000 gallons, monthly bills to Henderson's customers were increased by 35 cents from \$18.08 to \$19.15, or 3.9 percent.

3. During the 12 months ending April 30, 1992, Henderson purchased 472,833,800 gallons of water and sold 318,022,000 gallons.

4. Henderson's calculations are correct. The increase in the cost of purchased water is \$23,121.51, resulting in a purchased water adjustment of 7 cents per 1,000 gallons.

5. The purchased water adjustment of 7 cents per 1,000 gallons of water and the rates in Appendix A are fair, just, and reasonable and should be approved.

6. Henderson's tariff is correct and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 7 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after June 1, 1992.

2. Henderson's proposed tariff is approved.


3. Within 30 days of the date the adjusted rates are placed into effect, Henderson shall file a copy of the notice to its customers and verification that such notice has been given.
