During this time Mr Blevins was suppose to meet with 'us' on two separte ocassions between 6:30Am & 4:30Am to start digging. He never showed or even bother to call & cancel. After another week we called PSC again. At this time Mr. miracle ask if we would like to reopen the case. I explained how mad they had gotten before & was assured they could not hurt us by keeping water from us or raising the rates. After PSC called them the second time they have tried to come up with every excuse possible. We were told by the Nicholas County water Boards attorney that she would recommend they go ahead as planned. However; Mr Williams has come up with a code restriction plan that states utility lines are guaranteed easement to the back of the lots in our subdivision. Every line in the whole subdivision is ran in the front just as we are asking. We are not asking for nothing special just to be treated fairly like everyone else in the subdivision. We feel Mr. Williams is doing everything he can to put added Burden & expense to us for calling PSC. (The telephone company ran lines the second day & so did KU.) We can even get an assigned easement for the front of the lots he must go through from our neighbors but again this is not good enough. We also feel until we have someone from PSC to provide a hearing or to check into this in person he is not going to help us get water. We were told PSC was there to help us & thats all we are asking for. Thank-you
