

**Amendment to the Agreement
Between
NuVox Communications, Inc.
and
BellSouth Telecommunications, Inc.
Dated June 30, 2000**

Pursuant to this Amendment, (the "Amendment"), NuVox Communications, Inc. ("NuVox"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated June 30, 2000 ("Agreement") to be effective the date of the last signature executing the Amendment ("Effective Date").

WHEREAS, BellSouth and NuVox entered into the Agreement on June 30, 2000, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree to add the following provision to Attachment 2 and the Associated rates as set forth in Exhibit A of this Amendment, attached hereto and incorporated herein by this reference.

8.3.6 Rearrangements

- 8.3.6.1 A request to move a working NuVox CFA to another NuVox CFA, where both CFAs terminate in the same BellSouth Central Office ("Change in CFA"), will be subject to the applicable nonrecurring charges set forth in Exhibit A to this Amendment.
- 8.3.6.2 Upon request of NuVox, BellSouth shall project manage the Change in CFA or re-termination of a facility as described in Section 8.3.6.1 above and NuVox may request OC-TS for such orders and such OC-TS will be available at times designated by NuVox 24 hours a day, 7 days a week (except holidays). The applicable rates are set forth in Exhibit A.
- 8.3.6.3 BellSouth shall accept a LOA between NuVox and another carrier that will allow NuVox to connect a facility, or Combination that includes Dedicated Transport to the other carrier's collocation space or to another carrier's CFA.
- 8.3.6.4 BellSouth shall perform appropriate pre-service tests to ensure that transport facilities are delivered to the appropriate connecting points and that applicable industry standards of service are met. The Parties will use best efforts to ensure that testing for designed service is complete 24 hours in advance of the rearrangement. However, performance of the testing shall not impact the rearrangement due date or time unless

mutually agreed upon by the Parties or industry standards of service can not be met.

8.3.6.5 Where batch order processing is utilized the First NRC will apply to the first circuit of the batch and the Add'l charge will apply to each additional circuit in the batch. The applicable rates are set forth in Exhibit A.

2. All of the other provisions of the Agreement, dated June 30, 2000, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
