**AMENDMENT TO
INTERCONNECTION AGREEMENT UNDER SECTIONS 251 AND 252 OF THE
TELECOMMUNICATIONS ACT OF 1996
BETWEEN
BELLSOUTH TELECOMMUNICATIONS, INC.
d/b/a AT&T KENTUCKY
AND
MCIMETRO ACCESS TRANSMISSION SERVICES LLC**


The Interconnection Agreement effective November 5, 2006 by and between BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T") and MCImetro Access Transmission Services LLC ("MCIm") ("Agreement") effective in the State of Kentucky is hereby amended as follows:

1. Section 2 of the General Terms and Conditions is amended by adding the following section:
 - 2.1.1 Notwithstanding anything to the contrary in this Section 2.1, the term of this Agreement, as modified by this Amendment, will be extended and shall remain in effect for a period of three (3) years from November 5, 2009 until November 4, 2012, and thereafter as set forth in the Agreement.
2. AT&T and MCIm acknowledge and agree that the Agreement is, and shall remain, subject to intervening changes in law in accordance with Section 12 of the General Terms and Conditions of the Agreement.
3. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT (INCLUDING ANY AMENDMENTS THERETO) SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
4. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
5. This Amendment shall be filed with and is subject to approval by the Kentucky Public Service Commission and shall become effective ten (10) days following approval by such Commission.
