

**Amendment to the Interconnection Agreement  
Between  
Momentum Business Solutions, Inc. and  
BellSouth Telecommunications, Inc.  
Dated June 12, 2002**

This Amendment is entered into by and between Momentum Business Solutions, Inc. ("Momentum") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," to amend that certain Interconnection Agreement between the Parties dated June 12, 2002 ("Interconnection Agreement") to be effective as of the date of the last signature to the amendment.

WHEREAS, Momentum has changed the name of said business to Momentum Telecom, Inc. ("Momentum"), a(n) Delaware corporation.

WHEREAS, the Parties desire that the Interconnection Agreement be amended to reflect the correct corporate entity name.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of Momentum Business Solutions, Inc. (Momentum) in the Interconnection Agreement is hereby deleted for the state(s) of Alabama, Florida, Kentucky, Mississippi, South Carolina, and Tennessee in the Interconnection Agreement and replaced with Momentum Telecom, Inc. ("Momentum").
2. The Parties agree to delete Section 21.1 of the General Terms and Conditions and replace with new Section 21.1 as follows:

21.1 Every notice, consent, approval, or other communications required or contemplated by this Agreement shall be in writing and shall be delivered by hand, by overnight courier or by US mail postage prepaid, address to:




3. All of the other provisions of the Interconnection Agreement, dated June 12, 2002, shall remain in full force and effect.
