## AMENDMENT TO THE LOCAL WHOLESALE COMPLETE COMMERCIAL AGREEMENT BETWEEN AT&T-22STATE AND METROPOLITAN TELECOMMUNICATIONS

This Amendment (the "Amendment") amends the Local Wholesale Complete Commercial Agreement (LWC) by and between <u>AT&T-22STATE</u> and Metropolitan Telecommunications ("CARRIER"), hereinafter referred to collectively as the "Parties" and individually as a "Party", executed July 14, 2010 and shall apply in the State(s) of Alabama, Arkansas, California, Connecticut, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, Louisiana, Michigan, Mississippi, Missouri, Nevada, North Carolina, Ohio, Oklahoma, South Carolina, Tennessee, Texas and Wisconsin.

WHEREAS, the Parties acknowledge and agree that the provisions set forth in this Agreement are not subject to and/or required by the Communications Act of 1934, as amended ("Act") including, without limitation, Sections 251/252 of the Telecommunications Act of 1996 and any regulation or rule of the FCC or any state commission, and are not subject to negotiation and/or arbitration under Section 252 of the Act unless both Parties otherwise agree in a writing signed by both Parties.

WHEREAS, the Parties desire to add the Remote Call Forwarding class of service to the Local Wholesale Complete agreement as set forth below.

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

1.   - 16.9 In the event that CARRIER consists of two (2) or more separate entities as set forth in this Agreement and/or any Amendments hereto, all such entities shall be jointly and severally liable for CARRIER's payment obligations under this Agreement.
- 3. The Parties agree to add Section 19.1.3 to Section 19.1 of the General Terms and Conditions as follows:
  - 19.1.3 delivered by electronic mail (email) provided CARRIER and/or AT&T-22STATE has provided such information in Section 19.3 below.
- 4. The Parties agree to add 19.2.5 to Section 19.2 of the General Terms and Conditions as follows:
  - 19.2.5 notice by email shall be effective on the date it is officially recorded as delivered by delivery receipt.
- 5. The Notice Contact information contained in Section 19.3 of the General Terms and Conditions is deleted and replaced with the following:

- 6. Section 4.3 of Attachment 2 Local Wholesale Complete of the LWC Agreement is hereby added as follows:
  - 4.3.1 Remote Call Forwarding
  - 4.3.2 As an option, <u>AT&T SOUTHEAST REGION 9-STATE</u> shall make available to CARRIER an LWC class of service with Remote Call Forwarding capability ("RCF"). RCF service combines the functionality of End Office Switching, Tandem Switching and Common Transport to forward calls from the RCF service telephone number (i.e., the number dialed by the calling party) to another telephone number selected by the RCF service subscriber (Forward-to-Number). When ordering RCF service, CARRIER will ensure that the following conditions are satisfied:
    - 4.3.2.1 The End User of the Forward-to-Number agrees to receive calls forwarded using the RCF service (if such End User is different from the RCF service End User);
    - 4.3.2.2 The Forward-to-Number is equipped with sufficient capacity to receive the volume of calls that will be generated from the RCF service;
    - 4.3.2.3 The Forward-to-Number is not a public safety number (e.g., 911, fire or police number); and
    - 4.3.2.4 The Forward-to-Number may not be an international number.
  - 4.3.3 In addition to the nonrecurring and monthly recurring charges for RCF, <u>AT&T SOUTHEAST REGION 9-STATE</u> shall charge CARRIER the rates set forth in the <u>AT&T SOUTHEAST REGION 9-STATE</u> pricing schedule for End Office Switching, Tandem Switching, and Common Transport, including all associated usage incurred for calls from the RCF service telephone number to the Forward-to-Number.
- 7. The Parties agree to amend the Agreement's Pricing Schedule to include the LWC RCF service rates as set forth in Attachment A.
- 8. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 9. <u>AT&T-22STATE</u> will file a copy of the fully executed Amendment with the FCC under 47 U.S.C. § 211.
- 10. The effective date of this Amendment shall be ten (10) days after both Parties' final authorizing signatures have been affixed to this Amendment (the "Amendment Effective Date").
