## INTERCONNECTION AGREEMENT BETWEEN TRITEL COMMUNICATIONS, INC. AND

## SOUTH CENTRAL RURAL TELEPHONE COOPERATIVE CORPORATION, INC. FOR THE STATE OF KENTUCKY

This Agreement (the "Agreement") is made by and between Tritel Communications, Inc., a Georgia corporation ("Tritel"), and South Central Rural Telephone Cooperative Corporation, Inc. ("South Central RTC") (Tritel and South Central RTC hereinafter collectively referred to as the "Parties" and each individually as a "Party").

**NOW, THEREFORE,** for and in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Tritel and South Central RTC hereby covenant and agree as follows:

- 1. Pursuant to Section 252(i) of the Communications Act of 1934, as amended by the Telecommunications Act of 1996 (the "Act"), this Agreement hereby incorporates by reference, in their entirety, the rates, terms and conditions of that certain Interconnection Agreement effective May 1, 2001 by and between South Central RTC and NPCR, Inc., d/b/a Nextel Partners, and any and all existing amendments to said Interconnection Agreement as of the date of the execution of this Agreement, as approved by the Kentucky Public Service Commission (the "South Central RTC/Nextel Agreement") (attached hereto at Exhibit "A"), subject to the following:
  - (a) All references in the South Central RTC/Nextel Agreement to "NPCR and/or Nextel Partners" are deemed to be references to Tritel;
  - (b) All notices provided under this Agreement are to be provided to:
