INTERCONNECTION AGREEMENT PURSUANT TO
SECTIONS 251, AND 252 OF THE COMMUNICATIONS ACT
OF 1934, AS AMENDED

By and Between

South Central Rural Telephone Cooperative Corporation

And

ACC of Kentucky, Inc.

Adoption Agreement Pursuant to 47 U.S.C. Section 252(i)

This Agreement, which shall become effective on thirty (30) days following the date of the last signature of both Parties ("Effective Date"), is entered into by and between ACC of Kentucky ("ACC"), a Commercial Mobile Radio service provider, having an office at 14201 Wireless Way, Oklahoma City, OK 73134 and South Central Rural Telephone Cooperative Corporation ("SCRTC"), an Incumbent Local Exchange Carrier as defined in 47 U.S.C. Section 251(h), a corporation organized under the laws of the Commonwealth of Kentucky, having an offices at 1400 Happy Valley Road, Glasgow, Kentucky.

WHEREAS, the Telecommunications Act of 1996 (the "Act") was signed into law on February 8, 1996; and

WHEREAS, section 252(i) of the Act requires SCRTC to make available any interconnection, service, or network element provided under an agreement approved by the appropriate state regulatory body to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety; and

WHEREAS, ACC has requested that SCRTC make available the interconnection agreement in its entirety executed between SCRTC and Bluegrass Cellular, Inc., dated January 19, 2005.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, ACC and SCRTC hereby agree as follows:

1. ACC and SCRTC shall adopt in its entirety, the Bluegrass Cellular, Inc. Interconnection Agreement dated January 19, 2005 and any and all amendments to said agreement executed and approved by the Kentucky Public Service Commission as of the date of the execution of this Agreement. The Bluegrass Cellular, Inc. Interconnection Agreement and all amendments are attached hereto as Attachment 1 and incorporated herein by this reference. The adoption of this agreement with amendment(s) consists of the following:

2. The term of this Agreement shall be from the Effective Date as set forth above and shall expire as set forth in Section 2 of the Bluegrass Cellular, Inc. Interconnection Agreement. For purpose of determining the expiration date of the Bluegrass Interconnection Agreement, the effective date shall be February 18, 2005.
3. ACC shall accept and incorporate any amendments to the Bluegrass Cellular, Inc. Interconnection Agreement executed as a result of any final judicial, regulatory, or legislative action.
4. Every notice, consent, approval, or other communications required or contemplated by this Agreement shall be in writing and shall be delivered in person or given by postage prepaid mail, address to:

Unless otherwise provided in this Agreement, notice by mail shall be effective on the date it is officially recorded as delivered by return receipt or equivalent, and in the absence of such record of delivery, it shall be presumed to have been delivered the fifth day, or next business day after the fifth day, after it was deposited in the mails.
