Amendment to the Agreement Between Public Service Communications, Inc. and BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina and AT&T Tennessee Dated March 21, 2007

Pursuant to this Amendment, (the "Amendment"), Public Service Communications, Inc. - 1. Replace the Tandem Intermediary Charge(s) in Attachment 3, Exhibit A, of the Agreement with those reflected in Amendment Exhibit 1, attached hereto and incorporated herein by this reference.
- 2. All of the other provisions of the Agreement, dated March 21, 2007, shall remain in full force and effect.
- 3. This Amendment shall be deemed effective as of March 21, 2007 (Amendment Effective Date).
- 4. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
- 5. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof.
