NOTICE OF INTENT TO ADOPT INTERCONNECTION AGREEMENT

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the "Act"), 47 U.S.C. § 252
(i), Windstream Communications, Inc. ("Windstream") , through its undersigned representative, hereby
files its Notice of Intent to adopt the currently effective interconnection agreement between South Central
Rural Telephone Cooperative Corporation, Inc. ("South Central") and Sprint Communications Company,
L.P.

Windstream is a competitive local exchange carrier or CLEC certified with the Kentucky Public
Service Commission. South Central is an incumbent local exchange carrier or ILEC. Windstream
represents and warrants that it is an authorized provider of local telecommunications services in the
Commonwealth of Kentucky and that its adoption of the terms covers services in the Commonwealth of
Kentucky only.

The referenced agreement, which is to be adopted in its entirety, is identified by the Case number
2006-00199 on the Commission's publicly-available Internet site for approved agreements. The CLEC
party to this agreement is Sprint Communications Company, L.P. ("Sprint"). The original ILEC party to
this voluntarily negotiated agreement was South Central. The Commission approved the agreement in
Case No. 2006-00199.

Windstream intends to be bound by the terms of the unexpired agreement, anticipating that the terms of the agreement will be reproduced in their entirety, substituting Windstream in the place of Sprint in the agreement. A copy of the originally approved agreement is available in the record of Case No. 2006-00199.


The Commission has previously acknowledged the statutory right of carriers to adopt existing interconnection agreements by notice to the Commission. As the adoption arises from a statutory right, such a request may be reviewed expeditiously and promptly granted.

Windstream specifically requests that the Commission issue an order acknowledging the adoption and making the adoption effective the date of the order.

WHEREFORE, Windstream respectfully requests that the Commission issue an order:

- 1) Acknowledging the adoption by Windstream
- 2) Approving the request and making the agreement effective as of the date of the order ;
- and
- 3) Requiring South Central to file with the Commission a true and complete copy of the approved agreement.


