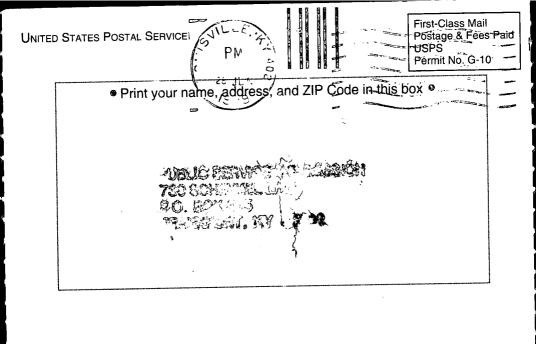

- 1. John Lawson, principal stockholder and president, of Spanish Cove Sanitation, Inc., (SCSI), upon receipt of the Complaint filed herein, forwarded same to the attorney for SCSI for proper handling and the timely filing of a response.
- 2. However, for reasons unknown to SCSI, no Answer was filed to the Complaint. Former counsel, J. Michael Poole, has been discharged, and undersigned counsel has assumed representation of SCSI. (Undersigned counsel had previously represented SCSI while an employee of J. Michael Poole, but had left the firm before the filing of the complaint herein, and had no knowledge of the Complaint until retained by SCSI after the entry of the Order of June 22, 1999).

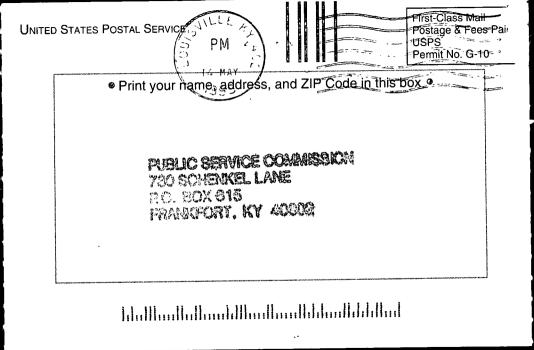
