### <u>ORDER</u>

On March 13, 2000, the Commission approved the transfer of ownership and control of the facilities of Covered Bridge Utilities, Inc. ("Covered Bridge") to Oldham County Sanitation District.<sup>1</sup> On March 30, 2000, Covered Bridge conveyed these facilities to Oldham County Sanitation District.<sup>2</sup> Covered Bridge now moves for dismissal of these proceedings on the grounds that the transfer of ownership of its facilities renders its application for rate adjustment moot.

Having considered the motion and being otherwise sufficiently advised, the Commission finds that:

1. The transfer of ownership of Covered Bridge's facilities renders these proceedings moot.

2. Covered Bridge's motion to dismiss should be granted.

### ORDER

Covered Bridge Utilities, Inc.
