ORDER

On July 6, 1999, SBA Towers, Inc. ("SBA") and GTE Wireless of the Midwest Incorporated (collectively, the "Applicants") filed an application seeking a Certificate of Public Convenience and Necessity to construct and operate a wireless telecommunications facility. The proposed facility is to be located at 240 Mason Road, Williamstown, Grant County, Kentucky. The coordinates for the proposed facility are North Latitude 38° 33' 32.5" by West Longitude 84° 35' 54.38".

SBA has provided information regarding the structure of the tower, safety measures, and antenna design criteria for the proposed facility. Based upon the application, the design of the tower and foundation conforms to applicable nationally recognized building standards, and the plans have been certified by a Registered Professional Engineer.

IT IS THEREFORE ORDERED that:

- 1. SBA is granted a Certificate of Public Convenience and Necessity to construct a wireless telecommunications facility to be located at 240 Mason Road, Williamstown, Grant County, Kentucky. The coordinates for the proposed facility are North Latitude 38° 33' 32.5" by West Longitude 84° 35' 54.38".
- 2. SBA shall immediately notify the Commission in writing, if, after the antenna tower is built and utility service is commenced, the tower is not used for a period of 3 months in the manner authorized by this Order.

On July 6, 1999 the Grant County Planning Commission received an application from SBA Towers, Inc. / GTE Wireless (6001 Broken Sound Parkway 4th Floor – Boca Raton, FL 33487), to construct a communications facility ("tower") at 240 Mason Road, Mason, Grant County, Kentucky.

The Grant County Planning Commission met on August 16, 1999 to review SBA Towers, Inc. / GTE Wireless's application and will make the recommendation of approval for this site with the following conditions:

1. The communications facility ("tower") have a permitted height of 350 feet (with possible adjustment to 400 feet).

2. The communications facility ("tower") have at least one parking space.

3. The communications facility ("tower") have all access drives and parking spaces paved with asphalt.

4. The communications facility ("tower") use barbwire on the top of the fences and slats within the chain links for privacy when building the compound.

5. The communications facility ("tower") have landscaping on all four sides of the compound.

6. A written agreement between SBA Towers, Inc. / GTE Wireless and the local governing body for the upkeep of all landscaping and equipment.

In addition, the Grant County Planning Commission would like to ask for the possibly to have the SprintCom Tower (Case Number 99-101) be review with regards to this tower — is there possible co-location for SprintCom on this tower. We would love to see only one tower in this area not two.

ITEM 3. TELECOMMUNICATIONS TOWER - 220 CRITTENDEN MT. ZION RD. - SBA/GTE

Chairman, John Lawrence declared the public hearing open at 8:40.

The commission reviewed copies of the site plan.

Mrs. Keene stated that they were asking the tower be built to 350 ft. she presented a letter from AT&T stating they would co-located at 300 ft. She said they were not asking for the paving or landscaping waiver.

Chairman, John Lawrence asked if anyone wished to speak for or against the request.

Mrs. Taylor questioned why there were 2 towers so close.

A representative of SBA stated that she had tried to contact SprintCom to discuss co-locating but her calls were never returned.

The Commission discussed that this site was better than the SprintCom site but if this site was approved there could possibly be 2 towers ½ mile apart.

The Commission decided to include along with their recommendation to the PSC a letter stating that they felt this site was a better location than the SprintCom site.

Chairman, John Lawrence declared the public closed at 8:50.

Steven Mann made a motion to approve the site and to include a letter to the PSC stating that the Commission prefers this site over the previously approved SprintCom site because this tower would allow for more co-location and was in a more secluded area. Vernon Webster seconded the motion. A roll call vote was taken: Vernon Webster: yes, Robert Worthington: yes, Sam Womble: yes, William Covington: yes, Marvin Faulkner: yes, Steven Mann: yes, Brooke Wooton: yes, Jim Weigel: yes. Motion passes 8 to 0.
