On September 7, 1999, North Marshall Water District ("North Marshall") submitted a revision of its tariff which would establish the rate for a six-inch meter connection. 

Dear Mr. Butler:

The North Marshall Water District has not had a 6 inch base meter charge established in the past. We have sent the necessary paper work to the Public Service Commission of Kentucky requesting an establishment of such a charge.

Until the new charge has been officially approved by PSC they have advised us to charge you based on a 4 inch meter charge of \$96.76 base rate and \$1.92 per thousand for usage. This charge is reflected in the enclosed bill.

We wanted to alert you that the base rate will raise as soon as approval is received in our office and will be implemented on the next billing thereafter. We expect the charge to be \$187.76, but this is not an absolute.
