#### <u>ORDER</u>

On November 23, 1999, Sentra Corporation ("Sentra") filed an application for a certificate of public convenience and necessity to qualify Sentra to obtain a gas franchise offered by the city of Gamaliel, Kentucky. Under the provisions of KRS 278.020(3), no utility may apply for or obtain any franchise from any city or other governmental agency until it has obtained a certificate of convenience and necessity from this Commission based on its finding that there is a need and demand for the service sought to be rendered.

Based upon the application and the copy of the franchise ordinance of the city of Gamaliel attached thereto, the Commission finds that there is a need and demand for gas service in Gamaliel, Kentucky. The Commission finds that the application is to obtain a franchise that was enacted on June 2, 1998. A Resolution of the city of Gamaliel, dated November 2, 1999, reinstates the franchise that had expired by operation of law.

The Commission is concerned that Sentra failed to file its application until after the franchise had been obtained. However, given the Commission's finding that gas

service is demanded and needed by the city of Gamaliel, and given the fact that Sentra has submitted its application prior to providing service, the certificate should nonetheless be granted.

The Commission's authority in such matters, pursuant to statute, is to find whether there is a need and demand for the service sought to be rendered. Therefore, no finding or determination is made as to the validity of any of the provisions of the franchise offered by said city or the manner in which any franchise is to be treated for rate purposes.

IT IS THEREFORE ORDERED that:

Sentra is hereby granted a certificate of convenience and necessity, 1. authorizing it to obtain a gas franchise in the city of Gamaliel, Kentucky.

If Sentra becomes the successful franchisee, it shall file with this 2. Commission two copies of the franchise agreement.

Nothing in this Order shall be construed as granting a certificate of 3. convenience and necessity to construct utility facilities in Gamaliel, Kentucky.

The Petition of Sentra Corporation respectfully states the following:

A. The Petitioner herein is a Kentucky corporation currently regulated by the Kentucky Public Service Commission pursuant to KRS Chapter 278 as a result of a Certificate of Public Convenience and Necessity granted in Case No. 97-429 by order dated November 17, 1999.

\*\*\*\*\*

B. The address of the Petitioner is 120 Prosperous Place, Suite 201, Lexington,
Kentucky 40509. The Petitioner's phone number is 606.263.3948 and its fax number is 606.263.4228.

C. This petition is a request for an order granting a Certificate of Public Convenience and Necessity to accept a franchise from the City of Gamaliel, Monroe County, Kentucky, to provide natural gas service. Pursuant to 807 KAR 5:001, Section 9(1) the following information is submitted:

1) The Petitioner's Articles of Incorporation are, pursuant to 807 KAR 5:001, Section 8(3), incorporated by reference to its pleadings previously filed in Case No. 97-429, In the

matter of: "A petition of Sentra Corporation for a Certificate of Convenience and Necessity to construct and operate a natural gas distribution system."

- 2) The City of Gamaliel, located in Monroe County, Kentucky has offered the Petitioner a franchise to provide natural gas service to the City of Gamaliel. Attached as Exhibit A is a copy of Ordinance # 5-98 dated June 2, 1998 passed by the City of Gamaliel that offers this franchise to the Petitioner.
- Attached as Exhibit B is a copy of Resolution # 1-99-00 dated November 2, 1999 that waives the default of the Petitioner for failing to provide service to Gamaliel prior to June 2, 1999 and extends the time within which the Petitioner must provide said natural gas service to the City of Gamaliel to December 2, 1999.
- Attached, as Exhibit C and D respectively are copies of the Petitioner's request for an opinion dated October 12, 1999 and the Kentucky Public Service Commission's response thereto dated October 20, 1999.
- 5) According to the 1990 census, the City of Gamaliel had a population of 462. City officials now estimate the population at approximately 490. The Gamaliel Elementary School has 212 students. Gamaliel has a police and fire department, as well as a pharmacy, grocery store and thirty other manufacturing and commercial businesses. Gamaliel has no natural gas service and there are existing holders of a franchise to provide natural gas to Gamaliel. Consequently, there is both a need and demand for service, and no duplication of services or facilities will result from the Petitioner's acceptance of the offered franchise.

- 6) On November 5, 1999, the Petitioner delivered notice to the Gas Branch, Division of Engineering, of its intention to build an extension line in the ordinary course of business to service the City of Gamaliel. A copy of this notice is attached as Exhibit E.
- 7) The extension line to Gamaliel is virtually completed and the Petitioner desires to accept the above referenced franchise and commence the delivering of natural gas to the City of Gamaliel by December 2, 1999.
- The Petitioner's proposed natural gas service to Gamaliel will be provided pursuant to the rates, and rules and regulations contained within Tariff No. 60-814 effective December 1, 1998.

WHEREFORE, applicant asks that the Public Service Commission of the Commonwealth of Kentucky make its Order granting a Certificate of Public Convenience and Necessity authorizing the Petitioner to accept the franchise from the City of Gamaliel.

#### ORDINANCE NUMBER 5-98

#### AN ORDINANCE GRANTING A FRANCHISE TO SENTRA CORPORATION, ITS SUCCESSORS AND ASSIGNS, TO OPERATE AND MAINTAIN A GAS SYSTEM IN THE CITY OF GAMALIEL, KENTUCKY, INCLUDING A SYSTEM OF GAS MAINS AND SERVICE LINES FOR THE PURPOSE OF TRANSPORTING AND DISTRIBUTING GAS IN, UPON, ACROSS, ALONG AND UNDER THE HIGHWAYS, STREETS, AVENUES, ROADS, ALLEYS, LANES, WAYS, UTILITY EASEMENTS, PARKWAYS AND OTHER PUBLIC GROUNDS OF THE CITY OF GAMALIEL, KENTUCKY

**BE IT ORDAINED** by the City Commission of the City of Gamaliel, Kentucky as follows:

SECTION 1: This ORDINANCE shall be known and may be cited as "GAMALIEL NATURAL GAS FRANCHISE ORDINANCE".

SECTION 2: For the purpose of this ORDINANCE, the following terms, phrases, words and their derivations shall have the meanings given herein. When not inconsistent with the context, words used in the present tense include the future tense, words used in the plural number include the singular number and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

- (1) "City" is the CITY OF GAMALIEL, KENTUCKY, a municipal corporation.
- (2) "Company" is SENTRA CORPORATION, the grantee of the rights under this franchise, which is authorized to do business within the state of Kentucky with a mailing address of 131 Prosperous Place, Suite 17A, Lexington, Kentucky 40509-1800, ATTN: William S. Daugherty, President.
- (3) "Person" is any person, firm, partnership, association, corporation, company or organization of any kind.

SECTION 3: There is hereby granted by the City of Gamaliel, Kentucky, to SENTRA CORPORATION, its successors and assigns, the right, authority, privilege and franchise to erect, construct, operate and maintain a system of gas mains, service lines, regulator stations and all other necessary and appropriate equipment and facilities for the transportation and distribution of gas in, upon, across, along and under the highways, streets, parkways and other public grounds in the present of future corporate limits of the City of Gamaliel, Kentucky, and in the environs of said City to import, transport, sell and distribute natural gas, within the City and its environs, for the supplying and selling of gas to the City (as a customer) and the inhabitants, institutions and business thereof; and for such purposes to construct, operate, maintain, renew, replace, repair and extend all necessary gas mains, service lines and other appliances, fixtures and facilities as may be necessary for said purposes including the transportation, distribution and sale of such gas to the City and the inhabitants thereof for domestic, commercial, industrial and institutional uses and such other purposes for which it is, or may hereafter be used.

EXHIBIT A Page 1 of 5 SECTION 4: This franchise and the rights herein granted shall take effect and be enforced from and after the effective date hereof, as required by law and upon the filing of acceptance by the Company, shall continue in force and effect for a term of TWENTY (20) years after the effective date. Provided, however, if the acceptance is not filed within THIRTY (30) days after the final passage of this ORDINANCE, the provisions of this Franchise shall be null and void. It is further provided, that in the event that a natural gas distribution system which makes natural gas available to all residences and commercial establishments in the city limits of Gamaliel is not constructed within one year of the effective date of this ORDINANCE, the provisions of this Franchise shall be null and void.

SECTION 5: All gas mains, service lines, fixtures, facilities and other appliances laid, constructed, maintained and operated by virtue of this Franchise shall be laid, constructed, maintained and operated in accordance with all applicable engineering practices and in full accord with any and all applicable engineering codes adopted or approved by the natural gas industry and/or engineering professions and in accordance with any applicable Statutes of the Commonwealth of Kentucky, Ordinances of the City of Gamaliel, Kentucky, and the Rules and Regulations of the Kentucky Public Service Commission or of any other governmental regulatory agency having jurisdiction over the Company. Said facilities shall be so constructed as not to interfere with the drainage, interfere with or injury any street, sewer or other public improvement which the City has heretofore made or may hereafter make in, upon, across, along or under any highway, street, avenue, road, alley, lane, way, utility easement, parkway or other public grounds of the City.

SECTION 6: When the highways, streets, avenues, roads, alleys, lanes, ways, utility easements, parkways or other public grounds are opened or any opening is made by the Company within the City, whether the same be made for the purpose of laying, constructing, replacing or repairing the mains, pipes and other appliances and fixtures of said Company, the Company shall place and maintain fixtures of said Company, the Company shall place and maintain all necessary safety devices, lights, barriers and warnings to properly notify all persons of any dangers resulting from such entrances and shall comply with all safety regulations required by the federal, state or local laws.

SECTION 7: In the event that at any time during the period of this Franchise the City shall elect to alter or change the grade or location of any street, alley or other public way in which the Company is maintaining gas mains, pipes of other appliances and fixtures, the Company, upon reasonable written notice by the City, shall remove, change or relocate its gas mains, pipes or other appliances and fixtures as necessary to conform to the proposed alteration, at Company's expense. However, the Company shall be reimbursed its relocation costs to the extent such reimbursement is authorized by a Federal or State Statute for either urban renewal development or street relocation, <u>AND</u> is funded by Federal or State funds.

SECTION 8: When any highway, street, avenue, road, alley, lane, way, utility easement, parkway or other public ground is entered by the Company it shall, within a reasonable time, but not more than thirty (30) days, restore the same to at least, its former conditions and in such a manner as to meet the approval of the City's codes inspector or other responsible agent of the City. However, such approval shall not be unreasonably withheld. In the event the Company shall fail

EXHIBIT A Page 2 of 5 to restore said street, avenue, road alley, lane, way utility easement, parkway or other public grounds to their former state as nearly as practicable, the City may itself, after giving the Company reasonable written notice, make the restoration and charge the costs thereof to the Company.

SECTION 9: The Company shall maintain public liability insurance in the amount of ONE MILLION DOLLARS (\$1,000,000.00) per occurrence and shall name the City of Gamaliel as an additional insured. Such insurance shall be with a company or companies approved by City, and Company shall provide City with certificates of such coverage, which approval shall not be unreasonably withheld. The Company shall at all times defend, indemnify and hold harmless the City from and against any and all claims for injury to any person or property by the reason of the failure of the Company or its employees to exercise due care and diligence in and about the installing and maintenance of said system, guarding trenches and excavations while said system is being installed or subsequent extensions, repairs or alterations are being made or generally in the operation and maintenance of said system, provided the Company shall have been notified in writing of any claim against the City or account thereof and shall have been afforded the opportunity to defend the same.

SECTION 10: The City and the Company hereby agree that this ORDINANCE shall, from time to time, be subject to Rules and Regulations adopted by the Company and approved by the Kentucky Public Service Commission or any other regulatory body having jurisdiction thereof during the term of this Franchise and shall also be subject to all Rules and Regulations adopted and approved by the Kentucky Public Service Commission itself; and that all such Rules and Regulations shall be and become a part of this ORDINANCE to the same extent and with the same effect as if said Rules and Regulations were herein set forth in full. The Company shall not be obligated or required to make any extension of distribution mains except in accordance with the provisions relating thereto as adopted or approved by the Kentucky Public Service Commission.

SECTION 11: Nothing contained herein shall be construed as preventing the Company from installing, placing, replacing, taking up, repairing or removing gas pipes, mains, service lines or other devices for furnishing gas service, from using any easements for gas service which are shown on any plat or plats of any portion of the City heretofore or hereafter platted or recorded or any easement which may hereafter be created, granted or dedicated for any such utility purposes by any person, firm or corporation whatsoever.

SECTION 12: No sale or transfer of the gas plant or system of the transfer of any rights under this Franchise shall be effective until the vendee, assignee or lessee has filed in the Office of the City Clerk an instrument duly executed reciting the fact of such sale, assignment or lease accepting the franchise terms and agreeing to perform all the conditions thereof.

SECTION 13: The Company shall pay to the City a franchise fee in the amount of ONE HUNDRED DOLLARS (\$100.00), payable within TEN (10) days of the effective date of this ORDINANCE. The Company shall further pay to the City during the term of this Franchise an amount equal to TWO PERCENT (2%) of the monthly gross sales from the sale of gas through the Company's distribution system within the Corporate Limits of Gamaliel, Kentucky, as a further and additional franchise fee or tax. This amount shall be payable each month so long as the Company shall supply and sell natural gas to the public within the Corporate Limits of Gamaliel, Kentucky,

The City shall have access at all reasonable time to the books of the Company for the purpose of determining the amount due to the City under this section. The Company shall also furnish the City an annual report showing the amount of sales within the Corporate Limits of Gamaliel, Kentucky.

SECTION 14: If any section or portion of any section of this ORDINANCE shall hereafter be declared or determined by a Court of competent jurisdiction to be invalid, the Company or the City, at their election (with notice to be given in wiring within THIRTY (30) days after such declaration or determination) may ratify or confirm the remaining portions of this ORDINANCE and upon such ratification or confirmation the remaining portions of this ORDINANCE shall remain in full force and effect.

SECTION 15: The Company, shall, within THIRTY (30) days after the passage of this ORDINANCE, file with the City Clerk of Gamaliel, Kentucky, its unconditional acceptance of the terms and conditions of this ORDINANCE. After the filing of such acceptance, this ORDINANCE shall constitute a contract between the parties hereto and shall (subject to the rights and powers vested in and Orders lawfully issued by the Kentucky Public Service Commission or such other regulatory body of the Commonwealth of Kentucky as may hereafter succeed to the rights and powers of the Kentucky Public Service Commission) be the measure of the rights, powers, obligations, privileges and liabilities of the City and the Company.

SECTION 16: All the privileges given and obligations created by this ORDINANCE shall be binding upon the successors and assigns of the Company, including those nonconflicting provisions which are now or may hereafter be attached herewith as addendum's.

SECTION 17: This Franchise is granted pursuant to the laws of the Commonwealth of Kentucky relating to the granting of such rights and privileges by municipal corporations. This ORDINANCE shall be subject to the approval of the Kentucky Public Service Commission. The Franchise shall take effect immediately, the public welfare so requiring it.

Dear Ms. Helton:

Sentra Corporation desires to provide natural gas service to the elementary school located in Gamaliel, Kentucky. While it is our opinion that this service would be an extension in the ordinary course of business pursuant to 807 KAR 5:001, Section 9 (3), we are requesting that you verify that opinion.

Sentra's proposed extension would consist of a 2" line of polyethylene (PE) SDR 11 PE pipe from a connection located east of Gamaliel in Monroe County, Kentucky, on the Clay Utility District (Clay County, Tennessee) line along the route indicated on the attached Exhibit A to the elementary school located on the west side of Gamaliel. In addition to the school, the proposed extension would provide natural gas service to individuals residing and businesses existing along the route.

There is no natural gas service to this area and no entity holds a franchise from the City of Gamaliel or a certificate of public convenience and necessity for Gamaliel. Previously, Sentra was granted a franchise by the City of Gamaliel that expired June 11, 1999. While Sentra intends to pursue obtaining another franchise and to construct a system to provide natural gas service to the City of Gamaliel, it was not able to finish the construction of its Fountain Run system in time to commence the process in Gamaliel before the expiration of its franchise. The proposed line will become an integral component of a community-wide system that Sentra plans to construct after renegotiating a franchise with the City of Gamaliel. Naturally, it is understood that Sentra must obtain the necessary rights of way and easements to construct the proposed extension.

Because there is no natural gas service to Gamaliel or existing franchise, there is no possibility for duplication of facilities or conflict of services.

The cost of the proposed extension is estimated to be approximately \$15,000 or less than 10% of Sentra's current physical plant. Sentra proposes to provide natural gas service to the customers along the proposed extension pursuant to the terms and conditions of Tariff No. 60-814 and the extension will not result in any requested changes in Sentra's existing rates.

Upon receipt of a favorable opinion, weather permitting, Sentra is prepared to construct the proposed extension within two weeks.

No entity is currently providing natural gas service to Gamaliel, Kentucky or the surrounding area.

No person, partnership, public or private corporation, or combination thereof shall commence providing utility service to or for the public or begin the construction of any plant, equipment, property or facility for furnishing to the public any of the services enumerated in KRS 278.010, except retail electric suppliers for service connections to electric-consuming facilities located within its certified territory and ordinary extensions of existing systems in the usual course of business, until such person has obtained from the Public Service Commission a certificate that public convenience and necessity require such construction.
