The first topic for this session will provide one (1) hour of training and will focus on accessing financial needs and on-going financing strategies that will build and demonstrate financial capacity for the utility. Having identified revenue sufficiency, credit worthiness, and fiscal management and controls as elements of financial capacity, this session will describe ways in which these essentials can be achieved. Helping utilities to become aware of funding sources, including interim and long-term financing, will be among Mr. Kirkpatrick's goals during this session.

The second topic for this session will provide one (1) hour of training and will update attendees with the latest activities of KIA. The passage and implementation of SB 409, as legislative commitment to the Governor's 2020 strategic plan, will be addressed as the driving force behind KIA leadership efforts. Mr. Recktenwald will emphasize the importance of utility participation in the early stages of management planning within the geographic boundaries that coincide with Area Development Districts. This presentation will include on-going and developing issues such as the updating of maps of uniform scale to illustrate system boundaries, uniform system of accounts, cost of service studies, fire protection, the status of municipals, addressing the issue of provision of wastewater services, and funding applications. The goal of this presentation is to encourage system personnel to take personal, collective, and community responsibility for achieving the benefits of safe drinking water for every Kentucky household by the year 2020, along with wastewater disposal practices that are consistent with source protection efforts.

TOPIC 3:2001 Session – Kentucky General AssemblyGary Larimore, Executive Director, KY Rural Water Association

The third topic for this session will provide one (1) hour of training covering the latest information on our State's 2001 Legislative Session. This will be the first session since voters approved annual legislative sessions. This portion of the program will identify key legislative issues so far during the session, report on action already taken, and explore the issues with action or resolution still pending. The goal of this training is to explain the intent of specific bills and to assess their significance to water and wastewater systems in Kentucky.

- TOPIC 1: Utility Office Management From The Academic Perspective

This session will provide one and one-half (1&1/2) hours of training and will include instruction on effective communications in utility office operations. WKU teaching staff will present current academic perspectives and curriculum topics that identify the best office practices, techniques, skills, policies, and procedures consistent with business office training currently available to college level students. The importance of effective communications in the water and wastewater office setting will be emphasized. What happens when the dissatisfied customer meets desk rage? How do we handle co-workers who bring their problems to work? What about passing rumors from customer to customer? In addition, Dr. Ray will show how technology enhances the effectiveness of water and wastewater office and administrative functions. TOPIC 2:What Consumer Confidence Reporting Has Taught Us So FarPRESENTER:- Clem Wethington, Program Manager, KY Rural Water Association

This session will offer one and one-half (1&1/2) hours of training on issues relating to consumer confidence reporting. With two years of reporting behind us, much has been learned about the preparation and publication of CCR's. The effectiveness of the consumer confidence report as a public relations tool has been clearly established, as well as its usefulness as a training instrument within the utility. This program by Mr. Wethington will provide an update on all the changes, additions, and refinements in place for the third year of consumer confidence reporting. Office procedures that effectively utilize the information contained within the CCR will enable utilities to demonstrate consistency, accuracy, and product and service quality.

The first portion of this session will provide one (1) hour of training. Mr. Dorman, recently named Executive Director of KY Public Service Commission, will present an overview of the PSC's regulatory role with emphasis on current issues crucial to water and wastewater utilities. Included will be the following:

The role of the Public Service Commission in water and wastewater issues The Governor's strategic water plan for 2020

Important current issues, including commissioner training, restructuring, water rates, extending service areas, and participating in inter-agency programs aimed at delivery of quality water and wastewater services at affordable prices for the consumer.

The benefits derived by those attending this session should include:

Gaining a better understanding of the role and relationships of system operators, managers, board members, and the regulatory agencies
Identifying the plans and resources in place for water and wastewater utilities
Learning how to take advantage of the programs and policies of our Public

The second portion of this session will provide one (1) hour of training. The goal of this training is to explain the mechanisms used by the KY PSC to order the development, investigation, promulgation, and revision of rules. The primary example used will be the current order known as ADMINISTRATIVE CASE NO. 386, AN EXAMINATION OF EXISTING WATER DISTRIBUTION MAIN EXTENSION POLICIES. Topics to be discussed will include:

An explanation of PSC's authority

The relationship of PSC to water districts, water associations, sanitary sewer

districts, and municipalities

An explanation of the stages of investigation of conditions and policies Collection of information regarding existing practices

Identifying perceived problem areas and potential solutions

Determining necessary revisions

Implementing revisions

This training will assist system personnel in developing a better understanding of the importance of their role in providing factual, detailed information when responding to PSC requests in administrative cases.

# TOPIC 3:Capacity – To Pump or Not To PumpVicki Ray, Manager, Drinking Water Branch, KY DOW

The third portion of this session will provide one (1) hour of training. Vicki Ray will present an update on the latest news regarding the Safe Drinking Water Act. Four major areas of interest to water and wastewater system personnel will be discussed. These include:

Capacity Development update – Technical, Managerial, and Financial Capacity New Regulations – the details from the primacy agency's perspective Operator Certification – Requirements for Kentucky's water and wastewater operators.

The first portion of this session will provide one and one-half (1&1/2) hours of training on labor, personnel, and employment issues which affect individuals, commissions, boards, associations, districts, and municipalities providing service in the water and wastewater industry. Topics to be addressed include the following:

Employers and employees – rights and responsibilities

Federal and State Laws - wage and hour, Fair Labor Standards

Act, and American's with Disabilities Act

Employment standards and practices

Update of court rulings regarding labor laws

Developing personnel policies for water and wastewater utilities

The goal of this training is to enable water and wastewater utility office managers and workers to better understand the laws and practices that assure effective results and that guarantee quality and service.
