THIS INDENTURE WITNESSETH: WHEREAS, The Cincinnati Gas & Electric Company, an Ohio corporation (the "Company"), executed and delivered to Irving Trust Company, now known as The Bank of New York, as Trustee (the "Trustee"), a certain First Mortgage, dated as of August 1, 1936 (the "First Mortgage"), to secure the payment of the principal of and interest on bonds of the Company to be issued from time to time in one or more series, and the Company has executed and delivered thirty-nine indentures supplemental thereto, which First Mortgage is recorded in Mortgage Book 299, page 15 in the records of the Recorder of the County of Butler, Ohio.

WHEREAS, pursuant to Article Eleven, Section 3 of the First Mortgage, as supplemented and amended, the Trustee, whenever from time to time requested by the Company and upon the conditions therein stated, shall release from the lien of the First Mortgage and said indentures supplemental thereto, mortgaged and pledged properties; and

WHEREAS, the Company has requested the release of certain property and has duly complied with the conditions aforesaid.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That The Bank of New York, a New York banking corporation, as Trustee, for and in consideration of the premises and of the payment of \$1.00 to it paid by The Cincinnati Gas & Electric Company, the receipt of which is hereby acknowledged, does hereby discharge and release from the lien and operation of the First Mortgage and said indentures supplemental thereto, any and all property that remains subject to the lien of the First Mortgage at the Woodsdale Generating Station (other than electric transmission assets) located in or near Trenton, Butler County, Ohio, including but not limited to the property, described in the attached Exhibit A, which is made a part hereof.

Provided, however, that this release shall not affect or modify the lien of the First Mortgage, or the lien of said indentures supplemental thereto, upon the residue of the property and premises therein described or any portion thereof.

The Trustee assumes no responsibility for the recitals contained herein.

Thence, continuing along said centerline, South 71°03'19" West, 310.53 feet;

Thence North 00°20'12" West, 1760.04 feet to a concrete monument, passing a concrete monument online at 26.38 feet;

Thence South 89'37'27" East, 164.34 feet to a concrete monument;

Thence North 00'04'47" East, 1185.45 feet to a concrete monument, passing a concrete monument online at 924.00 feet;

Thence South 89'55'13" East, 1134.78 feet to an existing concrete monument, passing concrete monuments on-line at 470.04 feet and 1129.78 feet;

Thence North 00°13'19" East, 1597.17 feet to an existing iron pin in the North line of Section 18, passing concrete monuments on-line at 5.00 feet, 797.17 feet and 1592.17 feet;

Thence, along the North line of said Section 18, North 89'54'05" East, 813.47 feet an iron pin and cap set;

Thence, along new lines of division, the following courses and distances:

South 00°16'01" East, 545.52 feet to a spike set, passing a set Mag nail on-line at 396.45 feet;

North 89°57'19" East, 346.33 feet to a Mag nail set;

North 01°22'06" West, 148.86 feet to a Mag nail set;

North 89°48'01" East, 322.81 feet to a Mag nail set;

South 00°14'50" East, 128.86 feet;

South 34°31'44" West, 56.58 feet to a spike set;
