REPLY TO THE RESPONSE OF COW CREEK GAS, INC TO THE COMMISSION'S ORDER DATED JUNE 30, 2009 AND TO B.T.U. GAS COMPANY'S JULY 16, 2009 RESPONSE

The Defendant, B.T.U. Gas Company, Inc. files the following Reply to the Response of Cow Creek Gas, Inc. to the Commission's order dated June 30, 2009, findings number 10 and number 11.

B.T.U. Gas filed a listing of affected customers as required by the Commission on June 30, 2009. According to the Commission's ruling these are the customers that Cow Creek must now provide service to. The ruling of June 30, 2009 was issued due to the petition of Sigma Gas, Cow Creek's successor in interest in this action. Sigma Gas requested these customers. In its response Cow Creek has filed a listing of the customers it has picked and has unilaterally decided it will accept as customers. BTU objects because this is not the ruling of the commission.

Specifically, in Finding 11 the Commission stated BTU is not authorized to serve the Salversville Magoffin Teen Coalition, Burke Arnett and Tom Bailey's

home and garage. However, Cow Creek gas is now refusing to provide service to these customers under their response. However, according to the Commission's ruling, this action by Cow Creek is not allowable.

Additionally, Cow Creek is refusing to provide service to the Dixie Church, a customer in the Dixie area that BTU is not longer allowed to serve. This action is not authorized by the commission's ruling either.
