(including the former NewSouth Communications Corp.), and Xspedius Communications, LLC on behalf of its operating subsidiaries (collectively referred to as "Joint Petitioners") jointly request the Kentucky Public Service Commission ("Commission") for an extension of time in which to file disputes which the parties may have regarding incorporation of the findings set forth in the Commission's March 14, 2006, and if necessary, the Commission's September 26, 2005 Order into the Joint Petitioners' interconnection agreements.

By Order dated June 2, 2006, the Commission ruled that "[i]f the parties have disputes regarding language for their interconnection agreement which they request the Commission to resolve, they shall file those disputes by no later than 30 days from the date of this Order."
