NOTICE OF WITHDRAWAL FROM ARBITRATION

Xspedius Communications, LLC, by and for its operating subsidiaries named in this proceeding ("Xspedius"), 1 respectfully serves notice of its withdrawal, with prejudice, from participation in the joint petition filed in this docket for arbitration of certain issues arising from negotiation of interconnection agreements with BellSouth Telecommunications, Inc. pursuant to 47 U.S.C. § 252(b) of the Communications Act of 1934, as amended. Xspedius and AT&T Kentucky (BellSouth) have reached a negotiated resolution of all issues submitted for arbitration in this proceeding. Xspedius' withdrawal, with prejudice, shall apply only to Xspedius and does not apply to any party that remains a petitioner in this proceeding.²

As a result of a merger, the Xspedius operating entities in Kentucky have been consolidated and renamed Time Warner Telecom of Kentucky LLC.

NuVox Communications remains a petitioning party in the proceeding.

NOTICE OF WITHDRAWAL FROM EMERGENCY PETITION

On March 1, 2005, Xspedius Communications, LLC, by and for its operating subsidiaries named in this proceeding ("Xspedius"), joined with several other parties in filing a Petition for Emergency Relief ("Petition") in this docket. By the Petition, the Commission was requested to declare that BellSouth may not unilaterally amend or breach its Kentucky interconnection agreements with the parties, or the Abeyance Agreement between BellSouth and the parties, to unilaterally implement certain provisions of the *Triennial Review Remand Order*.²

The Commission has not yet issued its order resolving all of the issues presented in the Petition. However, BellSouth and Xspedius have agreed on a mutually acceptable resolution of
