I want to make it clear, I never made an agreement oral or otherwise, allowing Fleming Mason to leave the trees and debris on my property.



Susan,

I have received a letter from Fleming Mason's attorney responding to the complaint. I'll address them in the same numerical order as listed in the letter.

1. Someone has removed the tree limbs that were hanging in the tree tops. The fences that were smashed to the ground have been pulled back up in an attempt to repair them. I'm not satisfied.

2. With the large size and amount of trees and debris pushed up to the side of the right of way I can not utilize my property in the same manner that I did before the cutting of the trees. I'm not able to drive my ATVs, hike, horse back ride or hunt through these areas. When I took the pictures attached to this note I had to carry my son, he was not able to cross over the debris. I purchased this property less than two years ago to utilize as a working farm and recreational reasons for my family. I worked very hard cleaning up the mess that had been left in the right of ways for years before I owned the property. The statement is made in the letter that I orally agreed to allowing the logs to be left on the side of the right of way and chip the brush, I never made this agreement. I have been ask to sign papers by the contractor of Fleming Mason, I can not understand why I should be required to sign any paper allowing Fleming Mason or their contractor to leave my property in a condition less than they found it. I have refused.

3. I was able to hike, ride ATVs, horse back ride, hunt and walk with my children through these areas before Fleming Mason cut the trees on my property, I cannot today. Fleming Mason asserts that the right of way is in as good or better condition. Opinions are subject to the effect of the situation and this situation I'm sure has not impacted anyone at Fleming Mason I'm the one living with the mess and the lose of the use of my property.

4. I will agree to allow Fleming Mason to remove all of the debris they have cut and left on my property. I cleaned up the mess they left from years ago I want my property returned to the same condition they found it.

I have attached pictures of the right of way, Sugar Creek, my driveway and the trash left on my property. I have stopped burning the limbs and debris that continues to collect on my driveway, I'm piling it up for Fleming Mason to remove when they decide to operate compliantly. I have attached pictures of the debris I removed from my drive and the creek in front of my house after the last rain.

Fleming Mason failed to address the trees, limbs and debris left in Sugar Creek and on the highway property where mowing will begin within the next few months.




