## MOTION OF LEVEL 3 FOR A PREHEARING CONFERENCE AND ENTRY OF A PROCEDURAL SCHEDULE

Level 3 Communications, LLC ("Level 3"), by its undersigned attorneys, moves the Kentucky Public Service Commission ("the Commission") to schedule a Prehearing Conference and adopt a Procedural Schedule. Level 3 has filed Petitions for Arbitration against BellSouth Telecommunications, Inc. ("BellSouth") in each of the nine states where BellSouth operates. In an attempt to make the hearing of these cases more manageable, Level 3 has proposed a regionwide schedule for these cases to BellSouth. Attached hereto as Exhibit A, is a proposed Procedural Schedule consistent with that region-wide schedule.

Because of the number of cases, and the other significant regulatory proceedings in which this Commission and the parties find themselves in this jurisdiction and others, the proposed Procedural Schedule for this case contemplates that the permissible nine (9) months granted the Commission to act on the Petition filed on February 20, 2004 pursuant to Section 252(b) of the Communications Act of 1934, as amended by the Telecommunications Act of 1996 (the "Act"), 47 U.S.C. § 252(b) will be exceeded. To remedy this, Level 3 proposes that the parties agree to waive any right to challenge any failure by the Commission to render a decision by June 13, 2004. As noted in the attached Procedural Schedule, the parties will file such a waiver letter by March 31, 2004 along with a Joint Issues Matrix and a proposed Joint Protective Order.

To finalize these procedural issues, Level 3 requests the Commission to convene a telephonic Prehearing Conference. A suggested date of April 2, 2004 is included in the proposed Procedural Schedule.
