2007 METER SAMPLING ANNUAL REPORT

Atmos Energy Kentucky Division completed the ninth year of its statistical sampling of their meter population with the following results:

A total of 5,857 meters making up 57 meter families were sampled. All meter families were tested in accordance with the sampling as set forth in the Kentucky Public Service Commission's Order (Case Number 99-059) dated August 24, 1999.

The meter sampling program is proving to be excellent for both the company and the customers. The customer and the company benefit for the same reason; poor performing meters will be identified and removed from service. This allows quality meters to stay in service for an extended length of time.
