

What does surprise me is that Carl Mays was mentioned in the story. He is the pitcher who threw the pitch that killed Chapman.

While Chapman is mostly remembered as the only baseball player to ever be killed in a major league game, most do not realize that at the time of his death he was the best shortstop in baseball and was the most beloved player in Cleveland. He had an Indians stolen base record that stood from 1917 until around 1980. He has numbers very similar to the legendary Pee Wee Reese and had better numbers than Phil Rizzuto and Ozzie Smith. In 1917 he was being compared to Honus Wagner.

Chapman finished his nine seasons with 334 sacrifice hits, 6th all-time in MLB, and the season that he was killed he was having his best season to date and the Indians won the World Series.

His wife never got over his death and poisoned herself. His only daughter, who


