On January 27, 2005 Commission Staff held a local informal conference in this case pursuant to notice to all parties of record. During the conference, Applicant proposed the alternate site depicted in the attached drawing to area residents on the condition that their intervention be withdrawn. The interveners unanimously agreed to accept the proposed alternate site and to withdraw their intervention in this matter. A Memorandum of Record regarding the informal conference was filed in this matter and served upon the parties on February 10, 2005, which included a drawing showing the exact location of the agreed upon alternate site. On July 21, 2005 the applicant filed exhibits depicting the location of the proposed alternate site and served a copy on all parties. No follow-up comments have been received from the interveners.

Applicant has met all filing requirements applicable to this proceeding as prescribed by the Kentucky Revised Statutes and the Kentucky Administrative Regulations. The Wireless Communications Facility ("WCF") that is the subject of the Application for a CPCN filed in this case is a vital element of the Applicant's wireless communications network, and is necessary to provide service in accordance with the provisions of Applicant's Federal Communications Commission license.

The Application that is the subject of this administrative proceeding was originally filed with the PSC on June 14, 2004, and has been pending before the PSC for nearly

14 months as of the date of this letter. Please submit this matter to the PSC on our application for a CPCN.

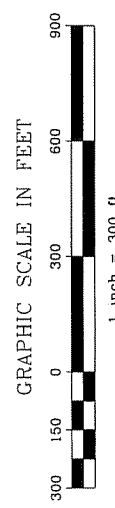
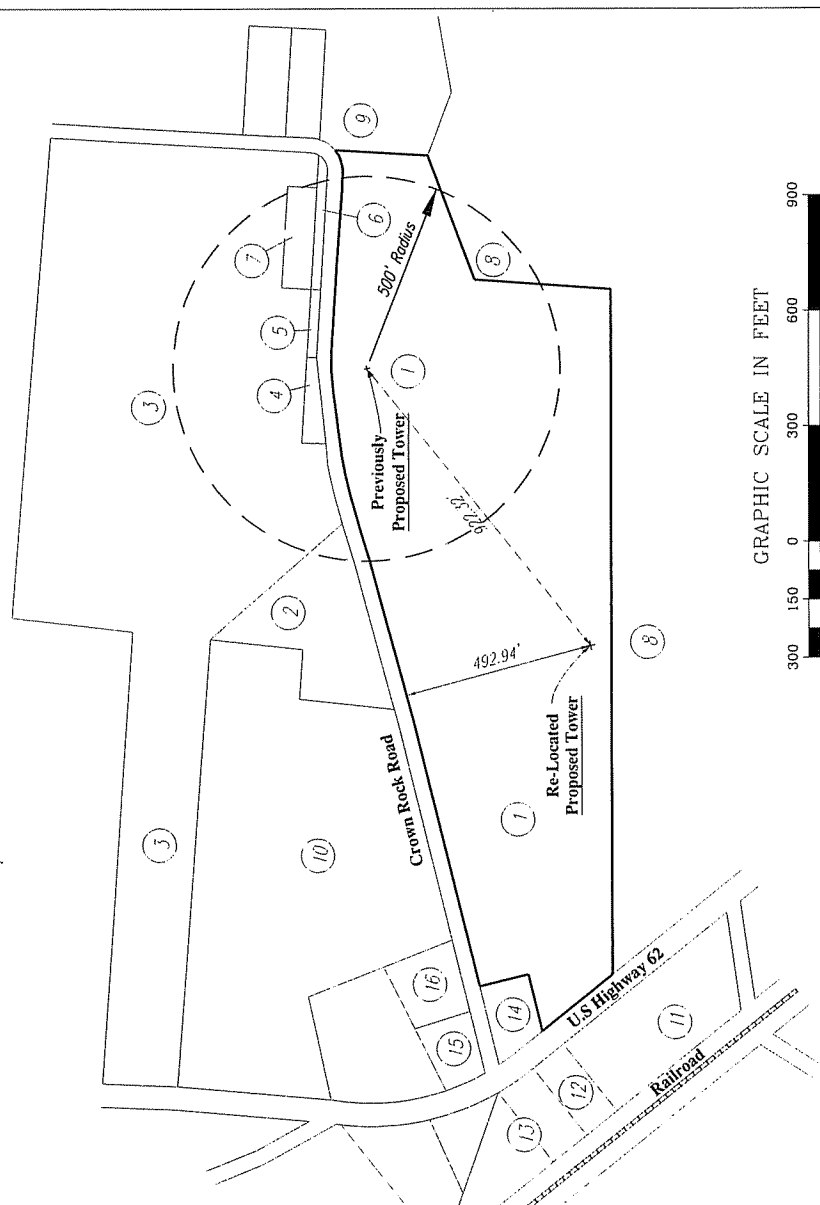
