ORDER

On October 7, 2005, the Commission granted a Certificate of Public Convenience and Necessity to BellSouth Mobility, LLC, d/b/a Cingular Wireless - Kentucky ("Applicant") to construct a wireless communications facility at Crown Rock Road, Big Clifty, Grayson County, Kentucky. The Applicant has since advised the Commission that it no longer requires the construction of the requested wireless communications facility because of the recent integration of certain facilities of AT&T Wireless Services Inc. into its network. The Applicant further moved for withdrawal of the granted Certificate of Public Convenience and Necessity.


Finding that the public convenience and necessity no longer require the construction of the requested wireless communications facility, the Commission HEREBY ORDERS that:

1. Applicant's motion to withdraw the Certificate of Public Convenience and Necessity for the requested wireless communication facility is granted.

2. The Commission's Order of October 7, 2005 is vacated and withdrawn.
