MOTION TO AMEND PROCEDURAL SCHEDULE

Now comes Jackson Purchase Energy Corporation ("JPEC"), by counsel, and moves the Commission to amend the procedural schedule appended as Appendix A to the Commission's July 20, 2005, order in the following respects:

1. Responses to Ballard Rural's (1) Request for Production of Documents and (2) Information and Data Requests and to KCTA's First Information and Data Requests should be filed by JPEC no later than August 3, 2005.
2. Direct testimony, in verified prepared form, should be filed no later than August 9, 2005.

The above two amendments to the procedural schedule were discussed at the informal conference held herein on July 26, 2005, and counsel for Ballard Rural and KCTA stated that they had no objection to same. In all other respects, the procedural schedule should remain intact.
