This letter is being sent on behalf of the above named entity pursuant to the Commonwealth of Kentucky Public Service Commission (Commission) order dated the 18th of May 2005 pursuant to case number 2004-00338. A copy of this order is attached for your convenience.

In this order Francis Water Company Inc. (Francis) was to investigate the feasibility of purchasing its water from a regional water supplier and any other feasible regionalization venture and is to submit a written report, on or before the 13th of June 2005, to the Commission. This analysis was done pursuant to this order.

Prices were obtained from the two closest utilities in an effort to determine the cost of purchasing the water. The results of these inquiries yielded the following rates:

Prestonsburg City Utilities would involve a line extension of approximately 15 miles. Given this issue along with the fact that they have a higher price leaves Southern Water as the only provider. The analysis is therefore based on the purchased water costing \$2.40/thousand gallons.

Francis expenses to produce its own water using figures determined by yourselves (Mr. Jack Kaniberg of the Public Service Commission) in the allocation of operation and maintenance expense in the rate increase of January 2005 yields the following as the cost to produce the water.

Francis currently has the need of approximately 1,950,000 gallons per month. If they purchase the water they must still maintain two employees for field and line repairs, customer service, valve repairs, meter reading, flushing lines, flushing hydrants, customer billings, meter record reports, building inspection, material purchases, and many other necessary functions. Given these factors yields the following as the cost to purchase the water.
