**AGREED ORDER**

This matter came before Hearing Officer H. Howell Brady, Jr., on July 27, 2005, pursuant to the Commission's Order of June 9, 2005. The Complainant, Howard B. Keen, appeared with counsel, the Hon. William K. Fulmer, II. The Defendant Carroll County Water District's Manager James L. Smith appeared with counsel, the Hon. Ruth H. Baxter. In an effort to resolve the pending Complaint filed by Howard B. Keen, the parties hereto have agreed as follows:

1. Howard B. Keen shall pay to the Carroll County Water District No. 1 the sum of \$1,465.00 in order to obtain water service. Further, Mr. Keen shall execute and deliver to the District the following documents: a.) water user's agreement on the District's standard agreement; and, b.) easement to the District on the District's easement form for the installation of a water meter;
2. The payment made by Howard B. Keen shall be credited toward the required meter deposit fee, and the costs of the bore under Clay Lick Road required to place a water meter on the real estate of Howard B. Keen. If the bore under Clay Lick Road is less than \$1,000.00, the District shall refund any sums not utilized for the expenses of the bore to Mr. Keen;

3. The District will use its best efforts to bore under the road at a location absent of rock;

4. The District shall take such steps to effectuate the bore under Clay Lick Road within twenty (20) days after approval by the Commission of this Agreed Order, and after payment by Howard B. Keen and receipt of all documents properly executed.




