MOTION FOR RE-HEARING


Come City of Maysville, Kentucky and Southern Mason Water District, by counsel, and hereby move the Public Service Commission to amend Ordering Paragraph 3 of its Order in the above case dated 28 January 2005 to amend the language that rates shall not exceed those rates charged to City of Maysville (“**Maysville**”) customers residing within Maysville’s corporate limits. Maysville has numerous customers now that reside outside the city limits of Maysville. The water and sewer rates include a surcharge of 25% of the water bill to all customers outside the Maysville city limits as shown on the Water and Sewer Rates attached as Exhibit C to the Application. Maysville has agreed to charge the current Southern Mason Water District rate for a period of five years. Beginning five years after the acquisition, water service will be provided to customers of Southern Mason’s water distribution system at the same rates as the other customers outside the city limits of Maysville. Southern Mason Water District customers would be charged the same as similarly situated customers. Maysville and Southern Mason Water District request that Ordering Paragraph 3 be amended to read in its entirety as follows:

“3. Beginning five years after the date of its acquisition of Southern Mason’s assets, neither Maysville nor the Utility Commission shall provide water service to customers of Southern Mason’s water distribution system at rates that exceed those rates charged to its customers residing outside Maysville’s corporate limits.”



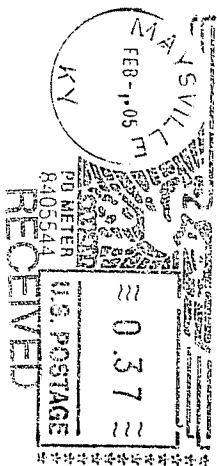
