RESPONSE TO THE PSC ORDER OF FEBRUARY 25, 2005



1. The Wheelwright Utility Commission is presently investigating the nature of the allegations and deficiencies outlined in the Comprehensive Inspection Report, and is working to correct any deficiencies noted.
2. The Wheelwright Utility Commission would ask for an informal conference with Commission staff to attempt an informal resolution of this matter.
3. The Wheelwright Utility Commission would move the Public Service Commission to continue hearing presently set for April 12, 2005, until after an informal conference may be held with Commission staff.


