The Applicant, Louisville Gas & Electric Company ("LG&E"), respectfully states:

The Post Office address of the principal office of LG&E 1. is 220 West Main Street, Louisville, Kentucky 40202.

2. LG&E is engaged in the business of supplying natural gas service in and to various cities and the inhabitants thereof within the State of Kentucky and has conducted such business for a number of years. LG&E is and for many years has been the owner of a separate franchise granted by the City of Pleasureville the ("City") to erect along, over, under or across the public ways and grounds thereof. LG&E's gas utility facilities used by LG&E in its supply of gas service in and to the City and the inhabitants thereof, which franchise, by its terms, have expired.

LG&E owns sources of supply of gas energy now being 3. furnished to customers in the City, and has distribution

4. LG&E has heretofore filed with the Commission a copy of its amended and restated Articles of Incorporation in Case No. 2003-00433.

5. There is and will continue to be a demand and need for gas service in and to the City and the inhabitants thereof; and LG&E desires to apply for and obtain from the City a franchise.

6. Should LG&E be successful in acquiring said franchise, it will file copies thereof with the Commission.

WHEREFORE, LG&E asks that the Commission enter an Order granting to LG&E a Certificate of Convenience and Necessity to bid for and acquire the described franchise from the City identified in paragraph 2 above.
