RE: Formal Application to add certain non-recurring charges and tariff language.

This is an application to revise language and certain non-recurring charges for the Cawood Water District. Attached is the non-recurring charge cost justifications and the proposed new tariff.

Cawood Water District is not requesting a water rate increase at this time. However, increased costs attributable to certain non-recurring charges can no longer be absorbed by the District. The customers affected by these increases will be the customers that cause the District to incur these additional expenses.

The District has previously filed income statements and balance sheets with the Public Service Commission. These income statements and balance sheets are currently on file with the Commission.

The District will publish the enclosed public notice of these requested rate revisions in the local newspaper for three consecutive weeks. The first notice has already been published and the newspaper ad is enclosed. We will follow up with a filing of the second and third newspaper ads along with an affidavit from the newspaper verifying that the notice was published for three consecutive weeks.

4. RETURNED CHECK CHARGE

A charge of **\$25.00** will be assessed to any customer whose personal check is returned due to insufficient funds or other reason for which the customer is responsible. Any customer who presents during any 12-month period two personal checks that are subsequently returned for insufficient funds or other reason for which the customer is responsible must make payment in the form of cash, money order or cashier's check for the 12 months following the presentment of the second returned check. During this 12-month period, the utility may refuse to accept from such customer any payment made in the form of personal check. In the event that a customer's payment is refused for the reasons stated above, the utility may consider the bill as unpaid and may exercise its right to disconnect service for nonpayment of bills, per procedures set forth in the Rule and Regulations section of this tariff and in accordance with Administrative Regulation 807 KAR 5:006, Section 14.

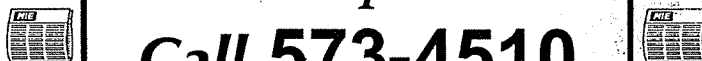
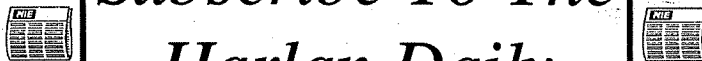

In accordance with the requirements of the Public Service Commission of the Commonwealth of Kentucky as set out in 807 KAR 5:069, Section 4, notice is hereby given to the customers of the Cawood Water District of a revision to the District's rate schedule as set forth herein. The proposed rate revision is required by Rural Development in connection with a loan by the RD to the District in the amount of \$350,000 to be evidenced by the issuance by the District of its Waterworks Revenue Bonds in such amount, which the RD has agreed to purchase provided the District meets certain conditions of the RD, including revising water rates as set forth below:

Current Monthly Rates — All Meter Sizes:

First 2,000 gallons	\$16.45 minimum bill
Next 8,000 gallons	5.54 per 1,000 gallons
All over 10,000 gallons	3.94 per 1,000 gallons

Proposed Monthly Rates — All Meter Sizes:

First 2,000 gallons	\$16.45 minimum bill
Next 8,000 gallons	5.54 per 1,000 gallons
All over 10,000 gallons	3.94 per 1,000 gallons

Pathfork Area

First 2,000 gallons	\$17.60 minimum bill
Next 8,000 gallons	6.69 per 1,000 gallons

The RD loan proceeds will be used in conjunction with a contribution from the District in the minimum amount of \$45,000; an RD Grant in the amount of \$350,000; an ARC Grant in the amount of \$225,000; a Ky. State Surplus Grant in the amount of \$500,000; a Ky. State Coal Severance Tax Grant in the amount of \$50,000; and a Harlan County Fiscal Court contribution in the amount of \$500,000 to finance the cost of extensions, additions and improvements to the existing waterworks system of the District, consisting of the installation of approximately 91,350 linear feet of 3, 4 and 6-inch water main and appurtenances; construction of a booster pumping station; and construction of a 53,000 gallon standpipe and appurtenances, including radio telemetry.
