**JOINT MOTION FOR EXTENSION OF TIME**

East Kentucky Network, LLC (“East Kentucky Network”), by counsel, and BellSouth Mobility d/b/a Cingular Wireless-Kentucky (“Cingular”) hereby jointly move the Public Service Commission of the Commonwealth of Kentucky (the “Commission”) for an extension of time through and including Monday, May 2, 2005, within which to file their third progress reports. As grounds for this motion, the parties state as follows.

1. Pursuant to the Commission's order of March 1, 2005, the parties are required to file with the Commission three status reports regarding the negotiations in this matter. East Kentucky Network and Cingular have timely filed their first and second progress reports with the Commission.

2. The third progress report is due April 20, 2005. East Kentucky Network, however, has a Board meeting scheduled for Friday, April 22, 2005, and the Board of Directors intends to discuss the negotiation with Cingular during the meeting. East Kentucky Network,


therefore, would like additional time within which to submit its third progress report so that the third report may reflect any issues raised during the Board meeting.

3. In addition, East Kentucky Network is transitioning to a new general manager and the April 22, 2005 Board meeting will be the new general manager's first meeting in that capacity with the Board of Directors.


4. Moreover, counsel to Cingular will be out of town the week of April 25, 2005.
