We received your inquiry this morning and are pleased to report that extensive negotiations, review of proposed agreements, and due diligence efforts have led the parties to reach agreement in principle on the collocation of Cingular Wireless antennas on two EKN towers. (Cingular calls these the "Penny" and "Brainard" sites.)

The last item of due diligence that Cingular Wireless needed prior to execution of the collocation agreements was a resolution from EKN authorizing signature by its authorized officer. We received the resolution today from EKN counsel. Cingular will be presenting collocation agreements to its authorized officer in a matter of days and then through its counsel tender these documents to EKN counsel for signature by its authorized officer.

Cingular Wireless, as a means of promptly informing the PSC of our progress, will report to the PSC within 21 days of today as to status of complete execution of the collocation agreements and we presume EKN will be willing to do the same. At such time, the parties will be in a position to request the PSC to take appropriate further action in this proceeding and the PSC will be in a position to consider what further action it should take.
